During the promotion of the bond program, a cornerstone of the promotion was that improvements would include building features that impact learning (acoustics, light, temperature control, alr quality, space, etc.). The features emphasized were those that have been proven to impact learning using empirical data.

I am requesting permission to make a 10-15 minute power point presentation at the June 20 board meeting on the impact of bond projects on learning. My presentation compares TAKS scores of homogeneous groups in campuses without improvements to those with the improvements. We track TAKS scores before, during and after facility improvements.

We are waiting on the 2006 results, but data so far indicates campuses with facility improvements realized TAKS improvements at a rate of 6% more than campuses without facility improvements. The ECISD data is consistent with the national trend . . . standardized test scores increased more at campuses with facility improvements than those without.

We also plan to use this data as a basis of entering a national facility impact on learning awards program.
