# **CFD: Accounting – Activity Funds Management**

Changes to CFD are predominantly wording changes that add the term "student club" along with student organization. Sponsor was also added to be responsible for the management of student activity funds along with the principal.

# **CQB: Technology Resources – Cybersecurity**

Eliminates the annual Cybersecurity training requirement for each employee. Allows the superintendent to specify employees that are required for cybersecurity trainings and the consequences of non-compliance.

### **DFE: Termination of Employment – Resignation**

Resignations of all contracted employees must be submitted to the superintendent or designee. The superintendent may designate the resignation of at-will employees to other administrators.

#### **DP: Personnel Positions**

SB 179 states that school counselors are to spend at least 80 percent of their work time on duties that are components of a comprehensive school counseling program (CSCP). The superintendent is to develop a revised job description for the school counselor if the board determines that campus duties and staffing needs prevent the school counselor from spending 80 percent of their duties on components of CSCP.

# **EHAA: Basic Instructional Program**

This is a new local policy that establishes guidelines for establishing human sexually curriculum and instruction for the district. The School Health Advisory Council (SHAC) will make recommendations to the board for the adoption of curriculum materials for the district's human sexuality instruction.

# **EHBC: Special Programs – Accelerated Services**

Revisions in this policy reflect HB 4545 change in requirements that move from Grade Placement Committees to an Accelerated Instruction Plan. The policy revisions also outline how a parent both file a complaint and request a teacher involving the Accelerated Instruction Plan.

#### **EIE: Academic Achievement – Retention and Promotion**

Eliminates outdated wording regarding grade advancement testing as a result of HB 4545.

# FDE: Admissions – School Safety Standards

Change to FDE now includes the term "disabled individual" in reference to the District collecting and maintaining data for a victim of continuous sexual abuse.

### FEA: Attendance - Compulsory Attendance

Adds getting a learner's permit or drivers license to the list of excused school absences.

### FEC: Attendance - Attendance for Credit

Changes to FEC recommend eliminating administrative details on documentation of attendance from policy and including them in the model student handbook. FEC changes also provide for attendance committees to consider "the best interest of the student" in awarding or denying credit. The adjustments also state that conditions for awarding of credit should be emphasize maintaining passing grades and mastering essential knowledge and skills rather than assigning programs to make up time missed.

### FFG: Student Welfare – Child Abuse and Neglect

Adjust the statement "cause to believe" to "reasonable cause to believe".

# **FL: Student Records**

The term "Grade Placement Committee" is replaced with "Accelerated Instruction Committee".
