Doors to be Wide Stile, as manufactured by Tubelite, Inc. Door hardware to include: Von Duprin 99 Series Exit Devices with associated trim, LCN closers, and Roton Continuous Hinges.

Glass at new door openings shall be 1" insulated, tempered (1/4-1/2-1/4), with Graylite tint and Low-E coating.




EXCLUSIONS:

- 4. All solid surface windows stools and/or new windows stools.
- 5. Drywall and plaster repair and associated touch-up painting.
- 6. Painting of any kind.
- 7. Removal or relocation of existing furniture, window treatments or personal articles within a normal workspace to and from the window opening and along the interior of the window opening.
- 8. Any responsibility for coordinating the location of new or modified suspended ceilings in relation to the new window / door system.
- 9. Any responsibility for coordinating the location and / or re-location of new and / or existing AC units, exhaust fans, louvers, fans, etc., in relation to the new window / door system.
- 10. Moving, disconnecting, reconnecting, or removal of existing conduits, gas lines, water lines, etc.
- 11. Any responsibility for coordination of moving, disconnecting, reconnecting, or removal of existing conduits, gas lines, water lines, etc. that may interfere with anchorage of new window / door system.
- 12. Any responsibility for errors resulting from the use of Mays Maune McWard shop drawings by other trades.
- 13. Any responsibility for coordinating the use of Mays Maune McWard shop drawings by other trades.
- 14. Any responsibility for variance of opening dimensions resulting in a change to material requirements, after receipt of approved Mays Maune McWard shop drawings.
- 15. Any damage to material finish or malfunction of window / system operation due other trades and / or construction debris.
