Correspondence

- We received notification from the **State Board of Education** (SBOE) that our Combined District Plan, which includes our CIP, College and Career Advising and Mentoring, and our Literacy Intervention Plan) has been reviewed and accepted and are all fully compliant.
- We received notification from the **Idaho Career & Technical Education** (ICTE) Department that Jessica Stapelman received two grants: one for \$3,555 for Animal Science curricula, and one for \$2,070 for various posters and other materials for the Ag department at Minico.

Information/Updates

- Avenues of Hope We are partnering with this foundation to raise money for our homeless students and those who are at risk. All of the money collected (<u>DONATE HERE</u>) will be matched by the foundation. As of December 13 we had raised \$880 in just two days!
- Extra Duty Stipend Schedule I met with Ty and Josh and have put together a proposal for adjusting these stipends to bring them closer to the state average and to simplify the schedule. I have submitted a report (attached) to the Board outlining our recommendation. I am sharing what has been done and am asking for another month to complete a middle school stipend schedule similar to this one, which we will present in January.
- Huntley Lawsuit We have received no new information.

• Staff/Building Visits:

We had some of our central office administrators cover for our elementary principals so they could have lunch together (November 29) and did the same for our secondary principals on December 4. During this time I covered at West Minico and enjoyed visiting classrooms and checking out things in the building.

I visited each classroom in Acequia Elementary on December 5 as well as made visits to classes at Rupert Elementary and East Minico.

The District runs like a welloiled machine every day while we serve over 4000 students!

• Committee/Community Meetings:
