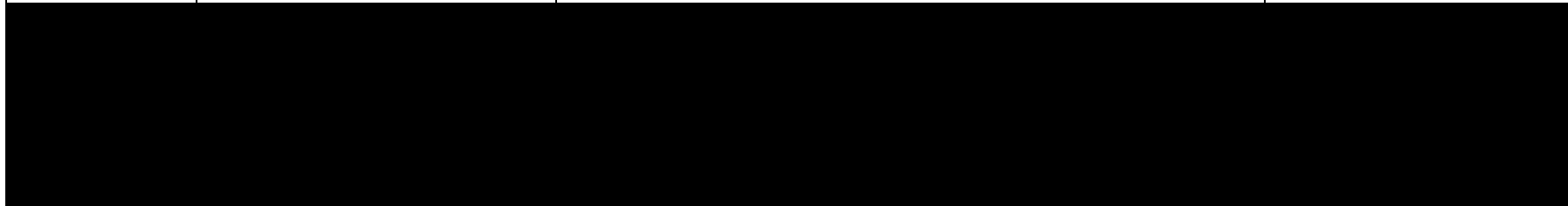

EIF(LEGAL)	Academic Achievement – Graduation	Language revised regarding academic evaluation and graduation criteria of special education students	Ott Adams Rogers
FDA(LEGAL)	Admissions – Interdistrict Transfers	Threat assessment records will be transferred to other districts through Sentinel	Ott Haugeberg
FDE(LOCAL)	Admissions – School Safety Transfers	Bullying was added to list of potential transfer reasons	Ott Haugeberg
FEC(LOCAL)	Attendance – Attendance for Credit	Attendance committees now established through administration and regulations rather than board; imposed conditions do not need to be an equivalent amount of “seat time”	Ott Haugeberg
FFAC(LEGAL)	Wellness and Health Services – Medical Treatment	Extensive revisions throughout regarding maintenance and administration of unassigned medication for respiratory distress; Temple ISD does not utilize unassigned medication	Ott Haugeberg
FFB(LEGAL)	Student Welfare – Crisis Intervention	Adds reference to the use of Sentinel for threat assessments	Ott Haugeberg
FOC(LEGAL)	Student Discipline – Placement in a Disciplinary Alternative Education Setting	Addition language regarding definition of violent conduct	Ott Haugeberg
FOF(LEGAL)	Student Discipline – Students with Disabilities	Peace officers cannot use restraint or taser on students fifth grade or below unless poses a serious risk of harm to self or others	Ott Haugeberg



EFB(LOCAL)	Instructional Resources – Library Materials	Complete rewrite due to opting out of School Library Advisory Council, emphasizes parental rights related to the selection and review of library materials and access to library records; establishes school library councils and mandates board approval for the purchase and donation of library materials	Ott Adams Rogers
FNCE(LOCAL)	Student Conduct – Personal Communications Devices / Electronic Devices	HB 1481 prohibits the student use of personal communication devices while on school property during the school day except in case of a documented need including special education, health or district safety requirement; District will store rather than dispose of confiscated devices	Ott Haugeberg
