- 4. Electronic Banking Al has directed Vivi Radford to man this process for us. Dr. Lett reported that this is not getting done. Vivi's direction is to work with Heather in setting this process up. Dr. Lett will be speaking with Al and the hope is to have this process up and going by September.
- 5. Dr. Lett will be presenting a bill to the board for the IPAD Cart that was purchased through local business donations. It was discussed to have the Foundation assist with this purchase through the Internet Account. There is a need to leave some funds in this account because of the three (3) monthly automatic payouts of \$15.00, \$18.00 and \$38.00 for PayPal and etc.
