The Board of Independent School District 308 met on Monday, September 23, 2024, in the Media Center and via Zoom. Board members reported attending the Community Action Committee meeting hosted by ICS.

Principal Michaelson's report included students in grades 11 and 12 will have the opportunity to attend the Education Fair at Central Lakes College September 24. Students in grade K-3 will take a field trip to Itasca State Park September 25. October 2 is mid-quarter. Parent-teacher conferences are scheduled for October 7 and 9 from 3:45-7:15 for students in grades PreK-12. A late start for professional development is on the calendar for October 9. And, there is no school for students and staff October 17 and 18 for the MEA break.

Certified staff representative, Olaf Netteberg gave an update of classroom activities including Mrs. Carrier's 7th and 8th grade students who are working on writing skills and exploring Ojibwe culture, and Ms. Mowder's creative writing class are creating podcasts. Mr. Netteberg indicated he would be attending a shop teachers' conference September 27, and the housing students have started construction of another house.
