

6-12 Mathematics - Curriculum Recommendation

To: Chanute Public Schools Board of Education
From: Kent Wire and the 6-12 Secondary Math Curriculum Committee
Re: Recommendation of Curriculum Materials for RMS/CHS Math Department

For the school board's consideration, the Chanute Public Schools 6-12 Math Curriculum Committee and Dr. Wire would like to recommend the adoption of Envision Math Curriculum from the Savvas Company for mathematics courses from 6th grade through Algebra II. The recommendation is for a 6 year adoption of materials as explained below and attached to this proposal. The recommendation timeline follows the current curriculum materials review and adoption cycle re-instituted in August/September of 2023 and edited in January of 2024, also attached to this proposal. In addition to the materials from the Savvas Learning Company, a quote for 11th grade Business Math is proposed and included.

The 6-12 math committee has been diligent in following the prescribed process to provide Chanute students the highest quality of curriculum materials and instruction as possible. The committee was formed by principals last spring and began work in Summer Institute and continued to work through last summer. A summary of the work that has led to our proposal today:

- 1) Curriculum Team Meetings: May 23,24,29, July 8, Sept. 11, Nov. 13, Dec. 11, Jan. 6, Jan. 17, and will continue to work on pacing guides through Summer Institute this year Feb. 12, Apr 9, May 14,21,22,23. This process, done right, takes a lot of time!
- 2) Review of the current Kansas Math Curriculum Standards
- 3) Alignment activities ensure what we teach is relevant to the standards
- 4) Assessment alignment - the team was purposeful in determining if our grade and course level standards aligned with the current state math assessment.
- 5) The team is finalizing preparations to share and publish the re-aligned, re-organized 6-12 math curriculum and instructional pacing guides to the district curriculum web site.
- 6) The team researched and surveyed new and/or recently published curriculum to find interesting and rigorous materials that are aligned with the Kansas Standards. The team attended a curriculum materials fair at Greenbush in November to sample numerous texts and resources.
- 7) During the course of their work, the curriculum committee reviewed math instructional materials from:
 - Amplify/Desmos Math
 - Great Minds/Eureka Math
 - Houghton Mifflin Harcourt (HMH) "Into Math"

- Reveal Math by McGraw Hill
- Considerations of our current sources
- Savvas Envision Math
- Along with many other samples collected along the way

8) The committee is recommending “restructure” or “return to the former structure” of the math program. In 2016 the state recommended that all schools at the “Algebra” level begin to teach integrated math. Chanute complied to this so that Algebra, Geometry and Algebra 2 became Math 9,10, and 11. The committee agreed that there were many things that were good about this change but,just as many challenges. So, courses we are recommending tonight:

- Math 6 and Math 6 Accelerated (same book, faster pace)
- Math 7 and Math 7 Accelerated (different book, combines 7-8th math outcomes)
- Math 8 and Algebra I (for RMS students who have accelerated)
- Algebra I for grade 9
- Geometry for grade 10 and accelerated students
- Algebra 2 for grade 11 and accelerated students
- Business Math - Personal and Family Finance for grade 11 in lieu of Alg. 2(not a Savvas product)
- Future recommendations for Pre Calc/Trig/Calc I not included in this proposal *

9) The committee reviewed our final two choices which were HMH Into Math and Savvas Envision. Our primary source for review is a publication called “Ed Reports” which is a non profit organization whose sole purpose is to provide unbiased information in order to enable teachers “to seek, identify and demand the highest quality instructional materials.” I opted for our team to “review reviews” from non-profit Ed Reports vs. using the Kansas Mathematics Instructional Materials Extended Review. I did this because Ed Reports compile many reviews from product users where, with the Kansas instrument, we would provide all of our own opinions regarding curriculum quality without having used it.

Both of our final 2 choices were very high quality as you can see:

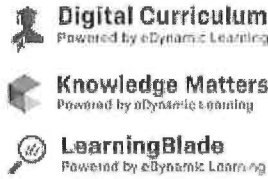
