

FINANCIAL INFORMATION FOR SUPPORT SERVICES





CUSTODIAL SERVICES

Training

On March 14th we gathered at the District office for our quarterly custodial training.

We were joined by Kevin Bissell from Pacific Power's "Call Before You Dig" and "One Call Concept "division. We asked Kevin to come in and conduct training on the importance of calling before doing any kind of digging. He pointed out to our custodial staff not to take it for granted that the contractors or volunteers that maybe digging on our property took all the proper precautions before doing so. And that we as a district should always call before any type of digging is conducted on district property.

Kevin also introduced us to the "One Call Concept" website. It allows our custodial staffs to enter requests for locating underground services prior to any digging. It will be another great tool for our custodian to use in keeping the district safe and compliant.

The training is part of Aramark's on-going commitment to ensure the safety of all employees and that the proper safety training and procedures are being followed.

The remainder of our training was also safety related. Our focus was on the 3 injury types that represent 70% of employee injuries nationwide are the top three OSHA Recordable drivers. These 3 are:

- Slip/trips/falls prevention
- Struck/injury by prevention
- Bodily motion prevention

We started by dedicating an entire week to each of the 3 subjects and then during our training discussed how we as a department can help prevent and ensure we are doing everything we can to help prevent these from happening.

And finally we reviewed Hazard Communication or other words known as "The Right to Know". This is extremely important in keeping our custodians safe while using different cleaning products daily.

Spring Break

During spring break, the custodial staff focused on deep cleaning of carpets. This is the prime time for this type of cleaning. They also conducted deep cleaning of classrooms, offices and restrooms. Again our custodial staff has done an outstanding job to ensure our students have the cleanest learning environment possible. Thank you for all your hard work and dedication.




Energy

These charts provide you with FY 13 and FY 14 energy consumption comparisons as of Jan 31st. We are up in consumption by 3.6% this year compared to the same time last year. Most of this was due to the colder temps we experienced in Dec which were on average 8 to 10 degrees colder than last year.

As you can see, five buildings are consuming less energy this year than they did last year.

- Evergreen -7.8%
- Lorna Byrne -2.7%
- IVHS -12.0%
- Food Service/Custodial Warehouse 16.6%
- Maintenance 0.2%





Print Shop

During April, the Print Shop made 752,007 Black and White copies, 38,374 Color copies, for a total of 790,441 copies. Approximately 600 books were bound.

We have also been organizing the warehouse and stock room, preparing for an inventory count; also, Rick has been comparing prices in anticipation of the summer supply orders.

Student Transportation

During the month of April we traveled 118,228 miles in Home-To-School transportation, equal to 4.75 trips around the earth (at the equator).

We arranged for Moser to begin repairs on the parking lot of our Ringuette facility. They have completed pothole repairs to the county lot used as an entrance to our properties. We are working with our Secondary programs to target lunch participation increases. Equivalent meals are calculated using sales from adult ala carte, student ala carte and catering. This total is divided by \$3.00 to calculate the total.

Learning does not end when school is over out; neither does a child's need for good nutrition. The Summer Food Service Program operated by the Three Rivers School District provides nutritious meals and snacks to all children within the Three Rivers and Grants Pass School District areas ... at no cost.

This helps children in low-income areas get the nutrition they need to learn, play and grow, throughout the summer months. Last summer, we were able to provide over 29,000 meals within Josephine County. We are looking for additional site opportunities that can host breakfast and lunch meal service. We are also partnering with each of our High School Athletic programs to provide meals at each sport camp or practice. Meal will be served from June 16 through August 222nd at (currently enrolled) 16 sites. Last year we provided for 17 serving sit
