RE: Purchase of used cargo van

Recommendation

Administration is seeking approval for the purchase of a used 2023 Chevy Express Cargo Van to replace an aging 2010 Cargo Van. The van will be purchased from a dealer for \$31,000. Since it is a used van, no bidding is required. The funds for this purchase are included in the 2025-26 budget.

Background

The District uses a cargo van primarily to transport items between schools. The existing van is 15 years old and has significant rust. (pictures attached)

Current Situation

The used van is in excellent condition with only 20,000 miles and there is still some manufacturer warranty remaining. Used vans with significantly higher mileage are selling for similar prices.

The dealer would give the District \$2,500 as trade in value for the old van.
