Minutes of the June 26, 2017 - Regular School Board Meeting

A motion was made by David Caviness and seconded by Thom Hulme to adopt the Coppell ISD 2017-2018 Student Code of Conduct, as presented. The motion carried 6-0.

Anthony Hill moved that the Board add, revise, or delete LOCAL policies as recommended by TASB Policy Service and according to the Instruction Sheet for TASB Localized Policy Manual Update 108. Judy Barbo seconded the motion. The motion carried 6-0.

No action was taken regarding proposed changes to Board Policy FDA (LOCAL): Admissions – Interdistrict Transfers.

Judy Barbo nominated Leigh Walker to serve as an official voting delegate to the 2017 TASB Delegate Assembly. The nomination was seconded by Thom Hulme. The Board voted 6-0 in favor of the nomination.

Leigh Walker nominated Judy Barbo to serve as alternate delegate to the 2017 TASB Delegate Assembly. David Caviness seconded the nomination. The Board voted 6-0 in favor of the nomination.
