Note - It is proposed to only apply the Discount to Textbook Rental and Lunch Supervision. Activity, while required, is passed through to the student activity accounts at the respective school buildings. Thus, in order to maintain an accurate 5% total Discount, the calculated discount on Textbook Rental and Lunch Supervision will need to be inflated. See the two proposed fee schedules (by Grade Level) below. Also, the separate Textbook Rental for K and Kindergarten Consumables have been eliminated. To offset, for Textbook Rentals, Kindergarten has been added to the 1-4 group. Lastly, Kindergarten has been added to the 1-4 group for Lunch Supervision.
