Elementary School Building Additions Project for Replacement of the Fire Alarm System

RECOMMENDATION: Administration recommends approval of Amendment of the GMP for Trautmann Elementary School Building Additions Project, for the replacement and upgrade of the school's fire alarm system, as required by the City of Laredo Building Code Ordinance. The cost for the proposed system upgrade is in the amount of \$136,160.05 (see attachment).

RATIONALE: The new Building Code Ordinance requires that all building additions that exceed 50% of the original existing building size must be completely upgraded to an EVACS (voice evacuation) type of fire alarm system. The new fire alarm system must be installed not only in the new building additions, but also in all the original existing building areas. The City of Laredo Fire Marshal granted a one-year grace period to UISD to upgrade the current fire alarm system within the original building, to have the fire alarm system completely upgraded to an EVACS system no later than August 1, 2017.

Staff has complied with all applicable federal, state and local purchasing policies and procedures in obtaining pricing information for the items listed above.

BUDGETARY INFORMATION: Proposed Fire Alarm System Upgrade Cost: \$136,160.05

Budget Source: 2013 Phase II Bond Proceeds for Fire Alarm Systems Replacements District-Wide: remaining available funds in the amount of \$1,687,069.00.
