### 1. Highview Elementary Extracurricular Clubs/Organizations – Schedule B

Mrs. Alice Reinke, Highview Elementary School Principal, is requesting the approval of two extracurricular clubs for the 2019-2020 school year. She would like to start a Robotics Club for 4<sup>th</sup> grade students and Student Council for 3<sup>rd</sup> and 4<sup>th</sup> grade students.
