(HB3 Required Goal) Goal 2*: Increased overall student performance in mathematics to 85% Meets Standard by 2028. The percent of 3rd grade students that score meets grade level or above on STAAR Math will increase from 53% to 65% by June 2024, 70% for 2024-2025, 75% for 2025-2026, 80% for 2026-2027, 85% for 2027-2028. (HB3 Required Goal) Goal 3*: The percentage of graduates that meet the criteria for CCMR will increase from 72% to 88% by August 2024 and increase to 95% by 2028. Background Annually, the Texas Association of School Administrators (TASA) and the Texas Association of School Boards (TASB) hold a joint convention. Information:

TASB will hold the Delegate Assembly on Sept. 13 in Houston, in conjunction with txEDCON. The TASB Delegate Assembly is where all members have a voice in the overall direction of the organization — from electing who will serve on the TASB Board to approving the education issues that will be included in the TASB Advocacy Agenda. As an Active Member of TASB, the board has the exclusive right to have a voting Delegate at the Assembly. The Navarro ISD Delegate will be the voice for the board at the Assembly, ensuring the priorities for the district and community are reflected in TASB's work. The Board may select a second trustee to serve as an Alternate. The representatives may trade off time on the Assembly floor to ensure your board's voting privileges are covered.
