Administration is recommending the proposed boundary changes effective the 2023-24 school year. These boundary changes are necessary to balance enrollment at these impacted schools. Meetings were held with parents of students affected by these boundary changes.

Veterans

The boundary for Veterans Memorial Elementary School begins at the intersection of Palmito Dr and Soria Dr. East along Soria Dr to Ejido Ave. South along Ejido Ave to Cielito Lindo Blvd. East along Cielito Lindo Blvd to Cuatro Vientos Rd. North along Cuatro Vientos Rd to an area parallel to Obsidian Blvd. East along Obsidian Blvd to the eastern UISD boundary line. South along the eastern boundary line to the city limits. West along city limits to US HWY 83 S. North along US Hwy 83 S to Cielito Lindo Blvd. East along Cielito Lindo Blvd to area west of Pearl Stone Rd. North along Pearl Stone Rd to Moonstone Rd. West on Moonstone Rd to Palmito Dr. North on Palmito Dr to point of beginning

Roosevelt

The boundary for Roosevelt Elementary School begins at the intersection of S. Ejido Ave and Melissa Dr. East along Melissa Dr to Cuatro Vientos Rd. North along Cuatro Vientos Rd to Wormser Rd. East along Wormser Rd to the UISD boundary line to an area parallel to Obsidian Blvd to Cuatro Vientos Road. South along Cuatro Vientos Rd to Cielito Lindo Blvd. West along Cielito Lindo Blvd to Ejido Ave. North along Ejido Ave to Soria Dr. West along Soria Dr to Cocoa Ln. North along Cocoa Ln, Roque Lp and Arzube Ln to Moon Ln. East along Moon Ln to S Ejido Ave and north to the point of beginning.

Perez The boundary for Perez Elementary School begins at the intersection of S US Hwy 83 and La Pita Mangana Rd. East along La Pita Mangana Rd. to Christine Ln. South along Christine Ln. to Moon Ln. East along Moon Ln. to San Rafael Ln. South along San Rafael Ln. and Los Cedros Ln. to Soria Dr. West along Soria Dr. to Palmito Dr. South along Palmito Dr. to Moonstone Rd. East along Moonstone Rd. to the western property line of Pearl Stone Rd. South along Pearl Stone Rd. to Cielito Lindo Blvd. West along Cielito Lindo Blvd. to S. US Hwy 83 and north to the point of beginning.
