

AGREEMENT

BETWEEN

KIDS U US INCORPORATED dba FUELING BRAINS

AND

GOOSE CREEK CONSOLIDATED INDEPENDENT SCHOOL DISTRICT

This proposal is submitted as part of the continuation of services under the existing Agreement dated September 18, 2023, between Fueling Brains and GCCISD. As per the Agreement, GCCISD holds the option to extend the contract on a year-to-year basis for up to five (5) additional years beyond the Initial Term, at its sole discretion. This proposal is intended to support the potential Renewal Term for the 2025-26 school year. No new agreement is required unless GCCISD determines otherwise, and all terms and conditions of the original Agreement shall remain in full force and effect unless explicitly modified in writing.

Component 1: Fueling Brains & Goose Creek CISD Early Learning Academies (Thematic) and Hopper Kindergarten Classrooms (Non-Thematic) July 1, 2025 – June 30, 2026

For the 2025-26 school year, Fueling Brains will continue serving PreK and Kindergarten students at GCCISD. Fueling Brains recommends an inclusive approach with targeted wrap-around services, including professional development and coaching. Fueling Brains implementation, combined with a comprehensive Professional Development and Coaching strategy, will ensure that brain development gaps in students are identified and proactively addressed.

Our team will collaborate with your educators and district leadership to strategically implement the Fueling Brains program, creating a cohesive professional learning community. Through this partnership, we will establish leadership and core competencies regarding developing Executive Functions for district students.

Fueling Brains Software

In the 2025-26 school year, Fueling Brains will work in the GCCISD Early Learning Academies (ELA) (approximately 840 students) and Kindergarten classrooms at Bonnie P. Hopper Elementary (approximately 120 students). These students will have a profile on the Fueling Brains Intelligence Dashboard, and teachers will have access to their roster of students, as well as their Executive Function levels. Educators will use the Fueling Brains Intelligence Dashboard for assessments and diagnostics, child intelligence planning, and classroom lesson

planning. Throughout the school year, Fueling Brains will schedule six assessments (BOY, PA2, MOY, PA4, PA5, and EOY) at intervals approximately 6 weeks apart for ELA classrooms and three assessments (BOY, MOY, EOY) for Kindergarten classrooms. However, once a student has reached mastery level, teachers can confirm their mastery status or conduct the full assessment if the teacher indicates it is necessary.

Coaching

To further support teachers at GCCISD Fueling Brains, the following coaching support will be provided:

- 50 hours of Program Support for District Admin to support GCCISD District and Campus leadership with the implementation of the Fueling Brains program.
- 150 hours of Instructional Coaching for GCCISD campuses to support Brain Coaches and TLC with coaching teachers on Fueling Brains implementation and fidelity.
- A caseload of 20 students from ELA campuses to work directly with the FB Behavior Specialist on specific student behaviors.
- A caseload of 30 students from anywhere in the District to work directly with the FB Behavior Specialist on specific student behaviors.

Professional Development

Goose Creek CISD teachers and staff will receive 8 days of professional development to ensure the effective implementation and delivery of the Fueling Brains program.

Brain Coach Certification

To build expertise in executive function and whole-brain development for students at Goose Creek CISD, a total of three staff members will participate in this course. Brain Coach certifications offer in-depth insights into the development of executive functions, including inhibitory control, working memory, and cognitive flexibility. They will learn how Executive Functions directly correlate to holistic and academic growth. Once certified, the Brain Coach will know how to incorporate this knowledge into Goose Creek CISD's curriculum and maximize a teacher's impact within the classroom through implementing the Fueling Brains approach. They will become a leader at Goose Creek CISD with a complete understanding of whole-brain development, Executive Functions, and how it integrates within the Fueling Brains suite of services. This "Train the Trainer" model will facilitate capacity building, enabling Goose Creek CISD to have increased on-site support for delivering the Fueling Brains program.

LMS Training Modules

Fueling Brains LMS Training Modules enable educators and administrators to expand their knowledge of Executive Function, Coaching, and effectively managing an FB campus, depending on their role and the assigned modules. These are self-paced online modules. Goose Creek CISD will have a total of 10 staff members assigned new LMS modules for the 2025-26 school year. The following modules will be provided:

- 5 Administrator Modules
- 4 Brain Coach Modules
- 3 Teacher Modules

The proposed quotes reflect the cost for Fueling Brains and Goose Creek CISD Early Learning Academy classrooms, as well as Kindergarten classrooms at Bonnie P. Hopper Elementary, for **Component #1**, **which is \$379,040.00**. In the event that Goose Creek CISD includes more or fewer classrooms in the Fueling Brains component of the Early Learning Academy, the total contract sum will be automatically adjusted to reflect that amount.

Kids U US Inc. O/A Fueling Brains Data Sharing Agreement

 This Data Sharing Agreement is entered into between Goose Creek Consolidated Independent School District (hereinafter "GCCISD") and Kids U US Inc. (hereinafter "FUELING BRAINS").

GCCISD and FUELING BRAINS may amend this agreement by mutual consent, in writing, at any time.

2. Purpose of DSA

The purpose of this data sharing agreement is to describe the duties and responsibilities to protect Student Data, including compliance with all applicable federal, state, and local privacy laws, rules, and regulations, all as may be amended from time to time. In performing the Services, FUELING BRAINS shall be considered a School Official with a legitimate educational interest, and performing services otherwise provided by the LEA. Provider shall be under the direct control and supervision of the LEA, with respect to its use of Student Data.

3. Period of Agreement

The period of this Agreement shall be in effect from July 1, 2025 to June 30, 2029.

4. Description of Data

The data elements to be provided are listed below. If additional access is needed, GCCISD and FUELING BRAINS may amend this agreement by mutual consent, in writing, at any time. Further details of the data and format of exchange will be listed in a data extract guide provided by FUELING BRAINS.

- 1. Classroom rosters
- 2. Student grades
- 3. Test scores
- 4. Absences/attendance
- 5. Behavior issues/referrals
- 6. TSI scores
- 7. SAT/ACT scores
- 8. Course schedules

5. Method of Transfer

GCCISD and FUELING BRAINS will employ industry best practices, both technically and procedurally, to protect GCCISD data from unauthorized physical and electronic access during transfer. Methods employed are subject to review and approval by GCCISD and FUELING BRAINS.

6. Security of Data

FUELING BRAINS will assume responsibility for data received from GCCISD and will employ industry best practices, both technically and procedurally, to protect data from unauthorized physical and electronic access. Methods employed are subject to review and approval by each Party.

FUELING BRAINS will comply with all applicable federal and state laws and regulations protecting the privacy of citizens including the Family Educational Rights and Privacy Act (FERPA).

GCCISD will be notified in the event the security, confidentiality, or integrity of the data exchanged is, or is reasonably believed to have been, compromised. Notification will take place within 12 hours of discovery. Appropriate course(s) of action will be determined based on inputs from GCCISD and FUELING BRAINS representatives.

Exchange of data between FUELING BRAINS and 3rd party contractors is subject to the requirements outlined in this agreement.

7. De-Identified Data

Upon completion of the project and/or contract, FUELING BRAINS will de-identify data collected to ensure student and LEA privacy. FUELING BRAINS agrees not to attempt to re-identify De-Identified Student Data. De-Identified Data may be used by FUELING BRAINS for those purposes allowed under FERPA and the following purposes: (1) assisting the LEA or other governmental agencies in conducting research and other studies; and (2) research and development of the FUELING BRAINS' educational sites, services, or applications, and to demonstrate the effectiveness of the Services; and (3) for adaptive learning purpose and for customized student learning. FUELING BRAINS' use of De-Identified Data shall survive termination of this DPA or any request by LEA to return or destroy Student Data.

8. Electronic Signatures

An electronic signature shall be deemed the same as an original signature; and shall have the same legal validity and enforceability as a manual executed signature.
