 - For each student, the grade points and college-level semester credit hours earned by the student in **Fall 2023, Spring 2024, and Summer 2024** are added together and averaged to determine the GPA



Each STAAR assessment is linked directly to the Texas Essential Knowledge and Skills (TEKS). The TEKS are the state-mandated content standards that describe what a student should know and be able to do upon completion of a course. Figure 1.1. Average Composite Scores: 5 Years of Testing*





Figure 1.2. Percent Meeting 3 or 4 Benchmarks: 5 Years of Testing*


