WHEREAS, an election was held in the McKinney Independent School District on the 3rd of May, 2025, for the purpose of electing school Trustees for Places 1, 2, 3, and 7.

WHEREAS, it is hereby found and determined that notice of the election was duly given in the form, manner and time required by law, and said election was in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceeding calling and governing the holding of such election; and,

WHEREAS, the returns of said election have been duly and legally made and submitted to the Board of Trustees for canvassing, and a tabulation of the returns for each polling place and for early voting, as canvassed and tabulated, reflect that the sum of the precinct totals of votes cast for each candidate as follows:

THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE MCKINNEY INDEPENDENT SCHOOL DISTRICT:

SECTION 1: All of the recitals contained in the preamble of this resolution are found to be true and are adopted as findings of the fact by this governing body and as part of its judgment.

SECTION 2: It is further found and determined that the results of the election are as canvassed and tabulated in the preamble hereof, and, a plurality of the resident qualified electors voting at said election having voted in favor of Larry Jagours in Place 1, Kenneth Ussery in Place 2, Corey Homer in Place 3, and Harvey Oaxaca in Place 7, the Board of Trustees hereby declares Larry Jagours to be elected to the position of Trustee for the position designated as Place 1, the Board of Trustees hereby declares Kenneth Ussery to be elected to the position of Trustee for the position designated as Place 2, the Board of Trustees hereby declares Corey Homer to be elected to the position of Trustee for the position designated as Place 3, and Harvey Oaxaca to be elected to the position of Trustee for the position designated as Place 7.

SECTION 3: The Secretary of the Board of Trustees is hereby authorized and directed to make the appropriate entries of information appearing in the tabulation of precinct results in the election register maintained by the District in accordance with provisions of section 67.006 of the Election Code.
