RECOMMENDATION:

It is recommended that the Board approve the following TASB Advocacy Resolutions. TASB will name a Delegate Assembly to adopt resolutions to present during the upcoming legislative session.

- 1. The use of student enrollment in the calculation of weighted ADA;
- 2. Plan to increase school funding over time to provide an amount by 2030 that equals or is better than the national per student average;
- 3. Develop formula driven mechanisms to be implemented annually to increase the basic allotment to keep up with inflationary pressures;
- 4. Propose legislation that reviews modifications made to the state maximum compressed tax rate;
- 5. Fund a statewide, univeral high quality full day pre-kindergarten program at a full time rate and include funding for facility modifications;
- 6. Fund and support special education programs and funding for facility modifications;
- 7. Allow for retired school personnel to fill vacant positions without penalties to individual or district that hires retired personnel;
- 8. Allow the extension of the educator certification waiver created by exodus of teachers leaving the profession and teacher shortage;
- 9. Allow retired school personnel to substitute vacant positions for up to 90 days instead of the current 20;
- 10. Repeal the A-F Rating and support a rating system that places emphasis on local accountability;
- 11. Revise the sanctions to campuses and districts that receive a D rating over two consecutive years as the same sanctions applied to F-rated campuses;
- 12. Adopt an accountability system that informs school districts about accountability standards no later than the beginning of the school school year;
- 13. Modify the current accountability system to increase the weight of the community based measures for district and campus ratings;
- 14. Make available state assessments in a student's native language for recent immigrants entering school at the secondary level;
- 15. Provide a state definition and tracking of long-term English Language Learners;
- 16. Allow school districts the flexibility to use of Technology and Instructional Materials Allotment funds to support digital transformation;

17. Support for public internet and Wi-Fi throughout the community; 18. Streamline the Texas Essential Knowledge and Skills to limit standards for each subject at each grade level; 19. Adequately fund the IMA to ensure that districts are able to meet increasing costs and adequatley fund required adoptions; 20. Adopt measures or initiatives that would designate the use of Foundation School Program funding for mandated programs; 21. Adequate funding to be provided for districts to provide a more equitable environment for all; 22. Revise the number of fire drills required each school year to decrease those but to increase the number of lockout/secure drills that are required;

Campus staffing is not based on student attendance but on student enrollment (i.e. 22:1 K-4 th grade).
