<u>ACTION</u>

A motion was made by Leigh Walker to adopt the Coppell ISD 2022-2023 Student Code of Conduct as presented. Nichole Bentley seconded the motion and the motion passed 6-0.

A motion was made by Tracy Fisher and seconded by Anthony Hill to approve the recommended compensation increases as presented. (This is 4% raise of control point for 187-day employees including teachers and nurses who will receive a \$2,570 increase. Librarians on a 197-day contract will receive a pro-rated increase. The beginning teacher pay for 187 contracts will be \$58,500 for 2022-2023. All other employees will receive a

4% increase on midpoint. Additionally, the district will increase the district's contribution to health care to \$350/month. The motion carried 6-0.

Tracy Fisher nominated Nichole Bentley to serve as an official voting delegate to the 2022-2023 TASB Delegate Assembly and Manish Sethi to serve as the alternate delegate to the 2022-2023 TASB Delegate Assembly. Leigh Walker seconded the nominations. The Board voted 6-0 in favor of the nominations.

Tracy Fisher motioned to nominate Nichole Bentley as a candidate for the Region 10, Position B, seat on the TASB Board. David Caviness seconded the motion. The Board voted 6-0 in favor of the nomination.
