**RESOLUTION TO ADOPT BUDGET
FOR FISCAL YEAR 2020-2021**

WHEREAS, the Illinois School Code (105 ILCS 5/17-1) requires boards of education to have a tentative budget prepared by a designated person or persons; publish notice of the availability of the tentative budget for public inspection and a public hearing thereon; hold at least one public hearing regarding the budget; and make the tentative budget conveniently available for public inspection for at least 30 days prior to formal action thereon; and

WHEREAS, the Board of Education published notice of the availability of the tentative budget for public inspection and a public hearing thereon; and

WHEREAS, on September 28, 2020, the Board of Education held a public hearing regarding the budget; and

WHEREAS, the Board of Education made the tentative budget for the 2020-2021 fiscal year conveniently available for public inspection for at least 30 days;

WHEREAS, the Board of Education finds and determines that it is necessary and in the best interests of the District to adopt the budget, as set forth in *Exhibit A*, for the 2020-2021 fiscal year.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Education of Geneva Community School District No. 304, Kane County, Illinois as follows:

Section 1. That the preambles to this Resolution are hereby incorporated by reference to this Section 1 as if fully set forth and restated herein *verbatim*.

Section 2. The fiscal year for the School District is declared to be July 1, 2020 through June 30, 2021.

Section 3. The Board of Education does hereby approve the budget attached hereto as *Exhibit A* for the 2020-2021 fiscal year, which time period has also been referred to as the 2020-2021 school year.

Section 4. That all resolutions or parts thereof in conflict herewith are hereby repealed, and this Resolution shall be in full force and effect forthwith upon and after its adoption.
