REPORTS: DISTRICT REPORTCARD. Jake Jackson, High School Principal, gave an update on the district report card for his campus. Mr. Jackson discussed the IBC (career ready) program. At this time, the district has 35 students earning a certificate in one of the following programs: Welding, Agriculture, Serve Safe Culinary, or Phlebotomy. If the students stay on target, we have 34 more students on track to earn their certificate before the end of school this year. Our goal for student certification was set at 25%, as of now we have achieved a 35.4%, and if all of the students on track complete the requirements, the district will have 70% completion. The students are doing well. Our teachers are doing an excellent job and I can say that West Rusk has great teachers, students, counselors and parents.

2022-2023 STATE ACCOUNTABILITY. Leah Bobbitt, Assistant Superintendent, presented the 2022-2023 State Accountability results for West Rusk. Our district received a C rating of 78% district wide. The results, released this month by the state, are two years old. Mrs. Bobbitt prepared a graph comparing West Rusk results with various schools in the state matching our demographics. Our teachers are continually working with the students in areas of need and are making progress each year. West Rusk has dedicated teachers working with our students and they are on track with student growth from year to year.
