  - A. Canvass May 3, 2025 Board of Trustees Election  
A quorum of the Board of Trustees was convened, and the Trustees considered the Order Canvassing Election Results; the Order was read in full and passed with all members present voting "AYE" as referenced in the Order Canvassing Election Returns, attached hereto and made a part of these Minutes.  
Mr. Coker moved, seconded by Mr. Birt, to certify the May 3, 2025 Board of Trustees Election with the election of Randy Campbell, Place 1, with 7,762 votes (52.71%), Jennifer Erickson, Place 2 with 7,722 votes (52.40%), and Chelsea Kelly, Place 3, with 8,775 votes (60.45%) as per the attached official results. Motion carried 5/0

Newly elected Trustees, Randy Campbell, Place 1, Jennifer Erickson, Place 2 and Chelsea Kelly, Place 3, took the oath of office and were seated as Trustees.

Mr. Coker nominated Trustee Washington as Vice-President. Ms. Erickson nominated Trustee Kelly as Vice-President. After calling for a vote, Trustee Washington was elected as Vice-President with a majority of votes of the sitting Trustees.

Ms. Kelly nominated Trustee Campbell as Secretary. After calling for a vote, Trustee Campbell was elected as Secretary with a majority of votes of the sitting Trustees.
