AGENDA ITEM :	Report Out of the Finance and Audit Committee and Approval of renewal of a one-year contract for independent auditor services from Grant Thornton LLP for an audit of the District's financial statements and a single audit of federal and state expenditures. The renewal will exercise the first of four (4) one-year options. The term of the contract will be May 23, 2019 through May 22, 2020.
DISCUSSION:	Independent audit services are required to perform an audit of the District's financial statements and a single audit of federal and state expenditures. Additional audit procedures may be performed to test compliance with state statute and board policies for procurement procedures.
	The cost of the one-year renewal is \$100,000.00 which is budgeted in Business Administrative department's FY 2018- 19 operating budget and subject to Board approval for the products and services described and in accordance with Board Policy CF (Local) and Texas Education Code Section 44.031.
