RESOLUTION LEVYING A SPECIAL TAX FOR  
SPECIAL EDUCATION PURPOSES FOR THE YEAR 2025**

**WHEREAS**, Section 17-2.2a of the Illinois School Code as amended by Public Act 83-930 provides that a school board of any district having a population of less than 500,000 inhabitants may, by proper resolution, levy an annual tax upon the value of the property of their School District as equalized or assessed by the Department of Revenue for special education purposes; and

**WHEREAS**, this School District maintains grades Pre-Kindergarten through eighth, and

**WHEREAS**, the Board of Education of Community Consolidated School District 89 can justify the expenditures for special education salary requirements,

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of Community Consolidated School District 89, DuPage County, Illinois as follows:

1. The Board hereby determines that it will levy \$3,800,000 for special education purposes.
2. That the Secretary of the Board of Education, or designee, is authorized and directed to file a certified copy of this resolution with the County Clerk of DuPage County, Illinois.
3. This Resolution shall be in full force and effect immediately and forthwith upon its adoption.
