Ms. Crooks began the discussion regarding mileage and annuity. Mr. Hayn stated that he has concern with the annuity. Ms. Kleckowski also expressed her concerns over the mileage stipend and annuity.

Dr. Vázquez Matos explained that although some districts do not have mileage and annuity in the contract, it is often done in an MOU. He explained the time commitment of the position outside of typical working hours. Board members Guss, Grippo and Daniels shared that the mileage and annuity is to compensate for the salary starting at a lower end in comparison to other districts. Ms. Cannata shared salary information in the MSAA contract. Discussion followed regarding putting the funds for the annuity into the salary.

Mr. Snyder discussed keeping the compensation competitive to avoid turnover and increase retention. Ms. Daniels expressed concern over the fixed annuity verse and percentage salary increase. Dr. Vazquez Matos discussed the pay of work in comparable districts.

MOTION: A motion to adjust the salary to \$170,000 annually and remove the annuity was made by Ms. Crooks and a second by Ms. Kleckowski.
