OLD BUSINESS: Emergency Management and E911 Services Director Kim Elkie updated the Committee that for the 2023 Hazardous Emergency Preparedness Grant they received \$2,775.73.

Sheriff Erik Smith gave an update on the Sheriff's Radio Project. The Board of Commissioners has given the Sheriff's Office \$100,000 towards the project and they will be looking for grants.

NEW BUSINESS: Discussion was made on 2024 LEPC meeting dates and times. The Committee approved the following dates and times for 2024 as follows:


**April 3, 2024 at 1:00 p.m.**


DIRECTOR’S UPDATE: According to the bylaws the Chair and Vice-Chair will be chosen for the LEPC at the next meeting.
