BACKGROUND/RATIONALE:

The College contacted 3 apartment complexes in Wharton, as well as other community colleges in our area to determine the current cost of student housing. After reviewing the cost of housing, and considering the benefits of being on campus, with 24 hour security, all utilities provided, as well as cable TV, and an expanded wireless internet service, it became obvious that we needed to update the current cost of on campus student housing. The last update to the on campus housing rates was in 2013 after the Mullins Hall renovation.
