Procurement Recommendation:

The Administration recommends approval of the Third Supplemental Agreement to the Contract for Design Build Services for the Construction of Seven Elementary Schools Between United Independent School District & Leyendecker Construction, Inc.. This is an Amendment consisting of a GMP Increase for Elementary School #27 (Veterans Memorial Elementary School) in the amount of \$164,185.93. THIRD SUPPLEMENTAL AGREEMENT TO THE CONTRACT FOR DESIGN-BUILD SERVICES FOR THE CONSTRUCTION OF SEVEN ELEMENTARY SCHOOLS BETWEEN UNITED INDEPENDENT SCHOOL DISTRICT AND LEYENDECKER CONSTRUCTION, INC.

This Third Supplemental Agreement is entered into this 6th day of May by and between the UNITED INDEPENDENT SCHOOL DISTRICT ("OWNER"), a political subdivision of the State of Texas, acting through its Board of Trustees, 201 Lindenwood, Laredo, Texas 78045, and LEYENDECKER COSNTRUCTION, INC. ("DESIGN-BUILDER"), 4220 Sanders, Laredo, Texas 78044.

RECITALS

WHEREAS, on June 2, 2014, OWNER and DESIGN-BUILDER entered into a contract entitled "Design/Build Contract between Owner and Design/Builder, for the Construction of five (5) new elementary schools and two replacement elementary schools ("Contract"); and

WHEREAS, the purpose of the Contract is to set forth the terms and conditions pursuant to which the Design/Builder is to undertake the architectural, civil engineering design involving the streets and right-of-ways to be undertaken along with the construction of the five (5) new elementary schools and two replacement elementary schools ("Project"); and

WHEREAS, OWNER and DESIGN-BUILDER desire to allow for changes in the Work (i.e. Work Order) under the Design/Build Contract as provided for and allowed under Article 7 of the "General and Supplemental Conditions for Building Construction" to the Contract.

NOW, THEREFORE, the OWNER and DESIGN BUILDER agree to enter into a Third Supplemental Agreement for a Change in the Work pursuant to Article 7, section 7.2, of the "General and Supplemental Conditions for Building Construction" of the Contract and affecting Elementary School Number 27 located in Cielito Lindo Subdivision in Laredo, Webb County, Texas, as follows:

Section 1. Changes in the Work. As provided under Article 7, section 7.2, of the "General and Supplemental Conditions for Building Construction," OWNER AND DESIGN-BUILDER agree to changes in the Work ("Work Order") affecting "Elementary School Number 27" located in the Cielito Lindo Subdivision, Laredo, Webb County, Texas and where said changes in said Work are set out in Exhibit "A" which is attached and incorporated and made part of this Third Supplemental Agreement to the Contract. The Scope of the Changes in the Work affect: (1) off site utility improvements, (2) on site utility improvements, and (3) providing additional kitchen equipment to said elementary school 27. The Guaranteed Maximum Price for Elementary School 27 will be increased by this Third -Supplemental Agreement in the amount of ONE HUNDRED SIXTY-FOUR THOUSAND ONE HUNDRED EIGHTY-FIVE DOLLARS NINETY-THREE CENTS (\$164,185.93).

Section 2. Fee. The changes in the Work as set out in Exhibit "A" by Design Builder shall not exceed ONE HUNDRED SIXTY-FOUR THOUSAND ONE HUNDRED EIGHTY-FIVE DOLLARS NINETY-THREE CENTS (\$164,185.93). Said amount will be paid to DESIGN-BUILDER from the construction contingency allowance set aside by the school district under the Contract.

Section 3. All of the terms and conditions of the original CONTRACT and not modified by this Third Supplemental Agreement shall remain in full force and effect.

Section 4. OWNER and DESIGN-BUILDER both acknowledge that OWNER is not prohibited from entering into an agreement for the design, construction, or renovation of improvements to real property not owned by the OWNER if the improvements benefits real property owned by OWNER which said benefit includes the design, construction, or renovation of roads, streets, sidewalks, crosswalks, utilities, and drainage improvements that serve or benefit the real property owned by the school district as provided and allowed under state law (Texas Education Code section 11.168(b)).
