Describe in your own words the mission and goals of OSBA.

There are two main components to the work of the OSBA. The first is to be an advocate for all students, regardless of geographic location, and by providing a single voice for board members related to legislative activities. Their second function is to provide services to districts that because of size may not be able to internally manage a particular function. They also provide a clearinghouse for consistent operation guidelines, allowing districts to think globally, and act locally.

There is a third component, equally important, of providing training and support to board members, so they can be as effective as possible in their local districts.

2. What do you want to accomplish by serving on the OSBA board of directors?

Continue to provide information to our local districts, incorporating a statewide perspective. To be a more effective advocate to our legislators, so they understand our long-term and short-term needs.

What leadership skills do you believe you bring to the board of directors? Give an example of a situation in which you demonstrated these skills.

I bring a willingness to share information with others and to involve them in the process. I have tried to avail myself of additional training to be a better board member for my local board, and a better representative to the OSBA board. After completing the Leadership Oregon sessions, I felt more confident as a member of the Oregon Delegation to the Federal Relations Network conference. With a limited amount of time available to us with our legislators, I thought I was able to provide them with accurate and concise information about our educational needs.

4. What do you see as the two most challenging issues faced by OSBA?

There will be a challenge in providing a consistent/cohesive voice for school districts as we continue to deal with implementation under the current No Child Left Behind legislation.

The second challenge is helping legislators understand the need for a meaningful and comprehensive change to the way we collect taxes in our state. With the current forecast looking like another downturn in revenue, we need to get off the roller coaster of budgeting for our schools.

While not every district in our area is experiencing this, many have pockets of rapid growth, and more growth looming on the horizon. We are all facing huge capital construction needs, both in new space for our students, and to maintain the investment in existing facilities.

NCLB continues to put undo pressure on all school districts, and without significant changes in reauthorization, it will continue to be a struggle to implement. Most pressing at this time is the change in Medicaid billing in support of our students. The potential impact to our budgets will be tremendous.

6. What is your plan for communicating with boards in your region?

I anticipate heavy use of email and face-to-face interaction at the regional meetings. Email provides a timely and cost-effective way to quickly spread the information. While many of the districts in this region are geographically close, we all seem to schedule our meetings on the same night.

1. Describe in your own words the mission and goals of OSBA.

OSBA's mission is to serve as the statewide voice for locally-elected school boards. In this capacity, OSBA lobbies on behalf of school boards, students, and public education; defends local control; partners with other education advocates; supports networking and sharing of information among school boards, and provides professional development opportunities.

2. What do you want to accomplish by serving on the OSBA board of directors?

I want OSBA to be a strong voice for students and public education in Salem and Washington, working in concert with other education advocates. OSBA provides an amazing opportunity for Oregon board members to share best practices, learn from one another, and be a powerful voice for students and schools.

3. What leadership skills do you believe you bring to the board of directors? Give an example of a situation in which you demonstrated these skills.

I'm always willing to advocate and fight for students and public education. In 2002-2003, I helped form the group Help Out Public Education (HOPE), and served as a key spokesperson, as we rallied thousands of parents and community members to push city/county leaders to pass a county-wide funding package to support Multnomah County schools.

4. What do you see as the two most challenging issues faced by OSBA?

As school funding continues to be inadequate, OSBA needs to partner with other education advocates to ensure a strong, effective voice in Salem. OSBA also needs to educate and encourage local school board members to help pass the Simple Majority and to defeat the many destructive measures on November's ballot.

5. What do you see as the two most challenging issues faced by your region?

Funding for school construction is a critical need both to declining enrollment school districts needing to replace buildings and to increasing enrollment districts needing to build new schools. The continuing punitive nature of NCLB and ongoing, inadequate funding are other significant concerns for our region and across the state.

6. What is your plan for communicating with boards in your region?

I will meet in person, as practical, as well as via e-mail, list serves and telephone. Because our region includes 3 representatives to the OSBA board, I will work with other reps to coordinate communications as appropriate.
