Please place on the agenda of the next board meeting of the Board of Trustees of ECISD a request to sell 1108 N Texas, Odessa, Texas, for $\$ 28,750.00$.

Pursuant to the inter-local agreement, which was set up to sell these properties, Trower Realtors has obtained a contract on the property and the buyer, Jerry Box and Zunna Box, has deposited $\$ 500.00$ with Linebarger Goggan Blair \& Sampson, LLP. The property is located at 1108 N Texas, Odessa, Texas, and had an appraised value of $\$ 65,011.00$ but was struck off for the minimum bid of $\$ 31,941.07$ in May, 2016.
