CONSENT ITEM

RECOMMENDATION:

It is recommended that the board approve the resolution required by the Office of the Governor for the Victims of Crime Act (VOCA) Grant Program application and award to Judson ISD for the 2026-2027 school year.

IMPACT/RATIONALE:

This is a new grant application and requires 20% matching funds from Judson ISD. The matching funds will be funded by the Meadows Mental Health Sub-Grant through CVS Grant Foundation - San Antonio Mobile Mental Wellness Collaborative and will not require any state or local funds from the general Judson ISD budget/finance process. Therefore, the grant will be able to fulfill all requirements through the combination of the two grant projects. This new grant will allow the district to continue to provide mental health counseling services through the Judson ISD Wraparound Center. Currently services provided through the Judson ISD Wraparound Center are being supported through a grant that expires at the end of the fiscal year and is not eligible for renewal or extension. This grant opportunity provides the district with a funding resource to continue to provide continued services through the Judson ISD Wraparound Center without the need for the district to absorb responsibility through state and local funding sources. This grant will specifically be used to support our mental health counseling services for students of Judson ISD. If awarded, the funds will be available October 1, 2026.

Resolution of the Board of Judson ISD Office of the Governor Victims of Crime Act Grant Program

WHEREAS, The Judson ISD finds it in the best interest of the citizens of Judson ISD, Bexar County, Texas, that the Office of the Governor (OOG) Victims of Crime Act (VOCA) be operated for the 2026-2027 academic year; and

WHEREAS, Judson ISD agrees that in the event of loss or misuse of the Office of the Governor funds, Judson ISD assures that the funds will be returned to the Office of the Governor in full.

WHEREAS, Judson ISD designates Dr. Milton Fields III as the grantee's Authorized Official (AO). The Authorized Official is given the power to apply for, accept, reject, alter, or terminate the grant on behalf of Judson ISD as the applicant agency. The Chief Financial Officer (CFO), Amanda Martinez, appoints as designee for Financial Officer for this application and, if awarded, financial management of this program April Klaerner, Accountant.

NOW, THEREFORE, BE IT RESOLVED that Judson ISD approves the application for and, if awarded, the acceptance of the grant award for the Victims of Crime Act Program through the Office of the Governor."
