### **Dorothy Martinez Elementary**

During recent attendance boundary discussions, the District explored the impact of future developments on the enrollment at Dorothy Martinez Elementary. With current attendance boundaries, these future developments would have significant impact to enrollment capacity at Bell Elementary, Paloma Creek Elementary, Sandbrock Elementary, Savannah Elementary and Union Park Elementary. After review of demographic impact research provided by Zonda Demographics, we propose adjusting the attendance boundaries of Bell, Paloma Creek, Sandbrock, Savannah, and Union Park Elementary Schools to allow this future development of the Dorothy Martinez Elementary School boundary.

# Fred Hill Elementary

During recent attendance boundary discussions, the District explored the impact of future developments on the enrollment at Fred Hill Elementary. With current attendance boundaries, these future developments would have significant impact to enrollment capacity at Cross Oaks Elementary and Providence Elementary. After review of demographic impact research provided by Zonda Demographics, we propose adjusting the attendance boundaries of Cross Oaks and Providence Elementary Schools to allow this future development of the Fred Hill Elementary School boundary.
