
The Southwest Arkansas Education Service Cooperative (SWAEC) is made up of nine school districts in rural southwest Arkansas. The counties we serve include Hempstead, Lafayette, Miller, and Nevada. We serve approximately 11,200 students and 1,000 public school teachers and administrators. The Co-op offices are located on the campus of the University of Arkansas Hope-Texarkana (UAHT). Our current facility opened in August 2010 through a partnership with SWAEC, UAHT, the City of Hope and the US Department of Agriculture, Rural Development Program.

SWAEC has worked to form partnerships with the Arkansas Department of Education and higher education for the purpose of benefiting our districts. Some of our services include: preschool programs for 3-5 year olds; special education services including education examiner, vision and behavior support; content specialist in math, literacy, science, and technology; career and technical assistance; gifted/talented services; support for novice teachers; bulk purchasing and printing services; professional development; and early childhood behavior assistance. We are actively involved with Henderson State University, Southern Arkansas University, and UAHT. We also work with several community coalitions, such as United Way, Kiwanis and Southwest AR Arts Council, to improve education for our children in southwest Arkansas.

We are pleased to share this annual report. The following reports and program summaries will provide insight to the vast array of programs and services provided to our member schools. We look forward to our continued partnership with our member districts as we serve students and educators in the evolving work of Pre K - 12 education.

- \* We had a number of teachers in the cooperative area pursuing National Board Certification. We hosted a support site that met once a month to help support these educators in the National Board process.
- \* SWAEC is a strong component of the department's alternate teaching program. We run the fiscal side for four sites and host our own year 1 and year 2 APPEL program. We graduated 14 teachers this April!
- \* SWAEC has worked with the AR School Board Association and APSRC to provide training specifically for the boards of SWAEC member districts. These meetings allow us to provide more targeted service for the needs of our area boards and allows them to save on travel as they do not have to go to Little Rock for their required hours.

## **Program Summary:**

This grant is designed to provide additional support to students in grades 7-12 in preparing for the ACT. Many students lost valuable instructional time during the pandemic, causing them to perform lower on the ACT. During the pandemic, the ACT was not given as often as in a nonpandemic year. Research proves that the more a student is exposed to the ACT the better they perform.

This program allows for all districts in Arkansas to opt-in for additional support for their students in taking the ACT. The support is intended to be implemented school-wide, allowing all students access and resources to improve ACT scores. The increased ACT scores could lead to additional financial and educational benefits for the students.

There were 261 school districts across the state that opted-in to OnToCollege. This program can be used at the school level in multiple ways. Schools are able to use this resource as a class during the school day, an afterschool program or a summer bootcamp. Training was provided to each district and the program will be provided for two years.

Chad Cargill provided 10 sessions for 924 students across the state. Each student spent three hours in a live session with Chad Cargill working on strategies for taking the ACT as well as content review. Chad has written a book with all of his tips and strategies and every student received a copy of the book to study further.

Cantrell and Waller Preparatory (CW Prep) is providing 10 sessions across the state to almost 1,000 students. In these sessions, students spend six hours digging into various content from the ACT. CW Prep also shares strategies with students when taking the test. Students leave the training with a one-year log-in to all the resources that were shared so they can use them to continue studying for the ACT.

We have also had Fetterman and Associates, which has 10 session for students. These sessions are six hour sessions where students are exposed to test taking strategies, ACT content and scholarship information.

All of these programs will be used again in the 2022-2023 school year. Arkansas Cooperatives are working to schedule and organize these events for all public, private and charter schools in Arkansas.

## **Program Summary:**

The Arkansas Professional Pathway to Educator Licensure (APPEL), a nontraditional licensure program, is an alternate route to teacher licensure administered by the Arkansas Department of Education. Enrollment in this program allows a candidate with a bachelor's degree or higher to be employed as a classroom teacher while completing the necessary requirements for a Standard Arkansas Teaching License. SWAEC is host to APPEL Year 1 and APPEL Year 2 participants in order to assist the needs of our schools in hiring qualified candidates. We are also the fiscal organization for three other sites around the state.

#### Goal:

Arkansas Better Chance (ABC) program is a high quality program that serves children, ages birth to five, with a variety of risk factors. However, the majority of availability is for three and four-year-old children. Providers are selected for their ability to offer a high-quality program. These abilities are assessed annually by early education professionals who evaluate each child and their ability for school readiness. The goal of Arkansas Better Chance classroom is to empower children with the skills needed to prepare them for kindergarten.

## **Program Summary:**

ABC Classroom (Arkansas Better Chance) is a center-based school readiness program for families of 3, 4, and some 5-year-olds. ABC staff consists of a trained coordinator, lead teacher, and a paraprofessional. The staff administered the Brigance Developmental Screening and Assessment to each child. Parents receive two parent/teacher conferences throughout the school year to discuss their child's development. The staff is involved in collecting and documenting information on each child for the purpose of entering data into the State Data System Work Sampling. ABC classroom can serve a total of 30 families per year.

### Major Highlights of the Year:

- \*Hatch Ignite, a digital platform for pre-K, was added to each classroom. The program covers seven domains and can be completed 15 minutes a day at school or at home. Frogstreet Curriculum was purchased for the classroom, and each staff member received training on utilizing the the curriculum.
- \* Every student received a preschool workbook, 2 children's books, crayons, scissors, paint, and pencils to take home for the summer to continue kindergarten readiness learning.
- \* Eight students were identified and referred for services with Early Childhood 3-5 Special Education. The students received services to include speech, behavioral, cognitive, PT, and OT.
- \* Arkansas Children's Week was full of fun and learning activities that included Arkansas State Park Ranger coming to speak, along with Smokey the Bear. Arkansas Fish and Game came and talked to students about boating safety and brought some wildlife friends, much to the surprise of the students. Local fire departments spoke to the students on fire safety.

The Behavior Support Specialists (BSS) affiliated with the Arkansas Department of Education - Special Education Unit provide training and coaching as part of the BX3 (Behavior eXtreme 3 – Training, Coaching, Empowering) project. The BX3 project is designed to build the local capacity of districts in working effectively with students with challenging behaviors and is aligned to the Arkansas State Systemic Improvement Plan.

This multi-year initiative has two goals. The first goal is to increase the knowledge base and capacity of educators regarding the development of legally defensible Functional Behavioral Assessments (FBA) and Behavioral Intervention Plans (BIP) based on evidence-based practices. This will be accomplished through providing district BX3 teams with professional development around effective supports for students exhibiting moderate and severe behaviors followed by on-site coaching opportunities. The second goal is to empower the BX3 team to develop, train, and sustain behavior-related procedures across the district to improve the outcomes of students with challenging behaviors.

100% retention rate from Year 2 to Year 3 for Cohort 2

#### Goal:

The goal of Career & Technical Education is to carry out the guidelines of the 2019 Perkins V Act. This federally funded program is for secondary and postsecondary career education programs to increase accountability and to emphasize student achievement strengthening opportunities for students. The Perkins funding is overseen by the Arkansas Division of Career & Technical Education. Another goal is to better prepare students for the workforce, postsecondary, and military. Based on data gathered from the consortia, a target for the eight Perkins indicators is provided to achieve academic attainment in literacy, science, and math, 4-year and extended graduation rates, post secondary placement, non-traditional participation, non-traditional program concentration, and program quality-attained post secondary credential.

### **Program Summary:**

The CTE coordinator for Southwest Arkansas Education Cooperative Perkins Consortium is required to write an annual Perkins application determining how to distribute/spend the funding for our area schools based on the indicator goals approved by the Arkansas Department of Career & Technical Education. Stakeholder Meeting, Comprehensive Local Needs Assessment, Start-up Applications, Concentrator Reports, Placement Reports, Certification Reports, Technical Assistance, CTE Enrichment Activities for Students, and Professional Development are also planned and provided by this office.

#### **Major Highlights of the Year:**

Throughout the year, SWAEC CTE Coordinator and the Texarkana Chamber of Commerce partnered to serve on the Miller County ACT Work Ready Community team. SWAEC CTE Coordinator and Hempstead County Economic Development Office also partnered to serve on the Hempstead County ACT Work Ready Community team. ACT Work Ready Community teams help promote WorkKeys and NCRC certifications and recognition and recommendation of the NCRC to attract business and industry to the area to promote economic development and growth. These teams will also implement a plan to recognize students with high scores on the NCRC.

Through the writing of Start-Up Applications in October, Lafayette County High School received \$33,203.14 for a new Pre-Educator Program of Study. Total for 2022-2023 Start-up Awards for SWAEC schools was \$33,203.14.

The CTE Coordinator also worked on site and via phone with counselors and administrators on scheduling and on new courses and off cycle start-up applications aligned with new Perkins V requirements for the upcoming year. On-site support for implementation of WorkKeys and computer science was provided for districts requesting it

The Southwest Arkansas Regional CTE Showcase allowed Prescott CTE Teachers to present their programs in March to community and school stakeholders including DCTE Associate Director Tim Johnson and DCTE Program staff.

The CTE Coordinator was contacted by Ledwell & Sons in Texarkana to tour their facilities with the Genoa Guidance Counselor. Opportunites for student internships and workbased learning resulted from this event. The CTE Coordinator created a presentation on WorkKeys and ACT Work Ready Communities for the Texarkana Chamber of Commerce in October of 2021. The CTE Coordinator presented to the Texarkana Chamber of Commerce Manufacturing Committee on CTE Programs in the Southwest Perkins Consortia in February 2022. In May, SWAEC CTE Coordinator worked with SCSC & DMESC CTE Coordinator to plan a WorkKeys & Computer Science Collaborative Support session to help principals and district testing coordinators better plan for implementation of Computer Science and WorkKeys by collaborating with their counterparts from across Southwest AR.

Starting early in the Spring Semester, CTE Coordinator worked on the the advisory committee for the Hempstead County FORWARD program. FORWARD is a pilot program of the Association of Public and Land Grant Universities and Ascendium and facilitated through the University of Arkansas Cooperative Extension. FORWARD aims to identify career pathways for potential workers and connect the community and current programs to support resources. Community members will continue to work together to improve workplace readiness for students and adults in Hempstead County.

The SWAEC Perkins V Comprehensive Local Needs Assessment Survey was released via Google Form in March 2021 and was revised in June 2022 to gather information to guide interpretations of the upcoming Perkins V regulations set to be implemented for Perkins funds in July 2022. The CLNA is a live document that is updated often as needs arise and where stakeholders identify needs for our programs.

A WorkKeys Implementation PD was held in June 2022 to support teachers and in successful implementation of WorkKeys Curriulum in order to help students score well on the NCRC.

In June 2022 Youth Mental Health First Aid Certification PD was offered for CTE Teachers in our area. CTE Teachers from Spring Hill, Nevada, Fouke, Genoa, and Blevins were certified in Youth Mental Health First Aid. The SWAEC CTE Coordinator hosted Regional Virtual PLCs for FCS, Agriculture, and Business teachers in the summers of 2021 & 2022 to support CTE teachers in their occupational areas and allow them to network with others in their content areas across Southwest AR.

- 1. Standards, Curriculum, and Pathways Successful implementation of computer science education in Arkansas requires the development and periodic revision of a comprehensive and vertically articulated set of K-12 computer science curriculum standards and courses, the local creation of well-developed curriculum that supports student learning, proper alignment of the K-12 expectations and opportunities to industry needs, and appropriate K-20 pathway development for students seeking formal computer science education beyond high-school.
- 2. Educator Development and Training Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to knowledgeable and informed computer science teachers. ADE, in collaboration with the Arkansas Educational Cooperatives and other partners, must support quality computer science educator development and training opportunities for all Arkansas educators and administrators.

- 3. Licensure Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to licensed and endorsed computer science teachers. ADE will continue and further research and implement, when appropriate, flexible licensure pathways and practices, based on legislation and regulation.
- 4. Outreach and Promotion Successful implementation of computer science education in Arkansas requires the active use of a broad range of mediums, digital tools, and human networks to properly communicate about the Arkansas Computer Science Education Initiative and respond to the needs and concerns of Arkansas students, educators, community members, and industry leaders.
- 5. Program Growth and Student Success Successful implementation of computer science education in Arkansas requires encouraging broad school implementation, supporting lighthouse schools to expand their programs, increasing statewide teacher capacity, growing student interest, and increasing stakeholder interest and support through the use of innovative programs and outreach initiatives.

## **Program Summary:**

Education Service Cooperatives, in partnership with the Arkansas Department of Education, administer the Computer Science Support Program for grades K-12 (Support for Integrating the Embedded K-8 Standards; 7th/8th Coding Block; and High School CS). In the interest of providing Arkansas educators with access to quality computer science (CS) professional development (PD), the Arkansas Department of Education (ADE) Office of Computer Science provided grants for ten Computer Science Specialists beginning in 2017. The Computer Science Specialists each serve the CS PD needs state-wide for all ESCs and public school districts. Assistance is provided to local school district educators through PD services, including sessions (ADE developed & customized based on needs assessments) at the cooperative, as well as support on-site in living the mission and striving for the vision of computer science instruction in Arkansas.

This involves supporting through various avenues including, but not limited to, instructional support for integrating digital learning, designing online instruction in a preferred online platform, supporting social-emotional learning in online and blended environments, facilitating effective PLC processes for both in-person and virtual teams, and incorporating student involvement and voice in digital learning.

#### **Program Summary:**

The Digital Learning Unit works within a state team to support Arkansas' planning, implementation, and evaluation of digital learning environments in Arkansas. The Digital Learning Unit has expertise in emerging online teaching and learning practices that allow for active learning; effective content authoring and lesson design methods that best serve digital education; strategies in helping educators transform system-centered practices into student-centered practices. The Digital Learning Unit offers operational support to state projects, Arkansas cooperatives, and public schools in the area of digital learning.

#### **New DESE DLU Website**

Arkansas Digital Learning Unit is migrating to the Canvas Learning Management System (LMS) as a digital platform where Arkansas educational agencies house and implement digital resources and professional learning. It is managed by the Digital Learning Unit. Currently, in addition to providing professional learning in the Connect2Digital.org platform, it is used to deliver the Arkansas Civics Exam. This platform supports over 100,000 users, including administrators, teachers, and students and will continue to provide support in the new Canvas LMS.

## **Goals:**

If we were to summarize why Virtual Arkansas is in existence, it would be this: to provide affordable and equitable educational access and opportunity for Arkansas students. According to Act 2325 of 2005, distance learning opportunities were employed:

- To help alleviate the teacher shortage
- To provide additional course-scheduling opportunities for students
- To provide an opportunity to access an enriched curriculum
- To develop and make available online professional development

Virtual Arkansas has specific goals that drive its operations. These goals are outlined below, along with the most recent results:

Help Address the AR Teacher Shortage - VA made courses and teachers available in all but one academic license shortage areas. - VA provided access to 97 full-time Arkansas certified teachers for local schools.

Provide a Wide Range of Courses for AR Students - VA provided access to 66 core courses, 34 CTE courses, and 12 concurrent credit courses for a total of 112 course offerings. - These courses provided opportunities to 36,282 Content + teacher enrollments, 5,848 Content Only enrollments and approximately 112,279 content partnership enrollments.

Ensure Educational Options for Economically Disadvantaged Students - VA courses were made available to all high poverty districts and utilized by 88.5% of all Arkansas districts with an 80% or higher FRL (free and reduced lunch) population. - VA offered preferred automatic concurrent credit enrollments for high poverty districts. One hundred percent of high poverty schools that submitted the necessary paperwork for enrollment during the early registration period were granted seats in the classes for which they registered. - 16,185 Content+ teacher enrollments came from schools with a 70% to 100% FRL population.

*Ensure Educational Options for Rural Students* - 62% of all Virtual AR Content+ teacher enrollments were from districts designated as rural - 81% of all concurrent credit enrollments were from districts designated as rural.

Provide Educational Options for Students with Scheduling Conflicts - VA courses can be taken at any time during the day, which provides flexibility in scheduling local course options to avoid scheduling conflicts. - This is particularly important for smaller districts, as they have many courses only available during certain periods of the day.

Increase the Number of Students Completing Career Focus Programs of Study and Participating in Work-Based Learning - 34 CTE courses were provided to 6,620 CTE enrollments - VA provided opportunities to students throughout the state in five full completer programs and seven partial completer programs.

Reduce the Number of Students who Enter College and Must Enroll in Remedial Courses - In the latest data available, 9% of VA concurrent credit students had a remedial course compared to 63.5% of non-VA students.

## **Program Summary:**

Virtual Arkansas is a supplemental State Virtual School (SVS) that partners with local Arkansas schools, the Arkansas Department of Education, and the local Education Service Cooperatives to provide 7th-12th grade online courses, resources and services to Arkansas schools, teachers, and students who might not otherwise have access to these resources and opportunities. #### **Program Summary:**

The 3-5 Early Childhood Program takes responsibility for coordinating efforts within the region to develop and establish programs providing special education and related services to identified preschool aged children (3-5 years) with developmental delays; collaborates in planning with the LEAs and superintendents in their districts for implementing activities to ensure the identification of eligible children; provides services to such children in accordance with individual educational plans developed for children with the least restrictive environment being the primary concern. Early Childhood Behavior services are available through the cooperative. Behavior referral procedures are in place at the Southwest Arkansas Education Cooperative through the Arkansas Department of Education ECSpEC website. The Behavior Interventionist has a number of specific duties listed below:

1) Working with parents and agencies when necessary; 2) Writing behavior plans, performing observations, assessments, and referrals; 3) Facilitating manifestation determination conferences; 4) collaborating with mental health providers; 5) conducting parent/teacher consultations; 6) assisting with the management of due process, crisis intervention, identification, etc.; 7) assisting with the management process related to autistic children; and 8) conducting in-service and staff training

For the 2021-2022 year, the Southwest Arkansas Education Cooperative Childhood 3-5 Program has the following data:

At December 1 count, we had a total of 244 children in services, 229 children were screened, with many of the screenings being completed at mass screenings for private schools and daycares. We had a total of 120 children that needed to be evaluated for services. Seventy children transitioned, needing services for kindergarten, while 55 transitioned to kindergarten ar and needed no services. For the 2022-2023 school year, we have 129 students that are returning and are currently in services or will be placed by the end of the current school year.

#### Goal:

The goal is to provide a resource for assessment and identification of children in 3-5-year-old programs who meet criteria for the state and federal definition of autism spectrum disorder and to assist in the development of educational and behavioral strategies that will offer students a greater opportunity for success in the classroom and community environment.

The Early Childhood Autism Team (A Team) consists of two speech language pathologists, two special education instructors and a behavior specialist. The use of a multidisciplinary approach in the educational diagnosis of autism provides additional validity to the eligibility determination process and provides information from an extended range of perspectives. Determining the qualification of a student under the definition of autism requires information relating to medical, psychological, educational and social characteristics of the student, as well as information regarding the school environment. Students are referred for assessment by parents, classroom teachers, and physicians. A screening instrument, based on the Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition (DSM-V), is completed by the classroom teacher, parent, and at least one member of the team. If the child meets criteria from the screening, specialized evaluation is warranted and scheduled. The team assesses students referred for specialized evaluation, interprets available data and subjective information and uses professional knowledge and judgment to determine eligibility. This specialized assessment uses the Battelle Developmental Inventory II (BDI-II) and the Vineland Adaptive Behavior Scales to assess developmental and adaptive skills. The Transdisciplinary Play-Based Assessment-2 uses play to assess cognition, sensorimotor, communication, and social emotional skills. The Preschool Language Scale-5 (PLS-5) and the Clinical Evaluation of Language Fundamentals-4 (CELF-4) assesses both receptive and expressive language, and the family completes an extensive family and social history. The Autism Diagnostic Observation Schedule-2 (ADOS-2) is used to assess the number and severity of autism related signs and symptoms. Team members perform extensive observations of the child in the natural setting and classroom environment. Additional scales and assessments are given, depending upon individual needs. All assessments are recorded for further reference and a typical specialized assessment takes approximately 12 hours per student. The team also provides support during the evaluation programming conference by presenting and explaining all evaluation results.

After evaluations are completed and the evaluation programming conference has been held, the team assists cooperative teachers, general education teachers, and parents in setting up visual schedules and/or implementing strategies to be used in the classroom or at home.

Data for 2021-2022: Thirteen children were referred and assessed. Of the thirteen, eleven met the criteria for autism spectrum disorder.

#### Goal:

To provide consultation, direct and support services to students who are blind or visually impaired, to their parents and to the school, center and related staff.

#### **Program Description:**

The Educational Vision Consultant/Orientation & Mobility Specialist housed at SWAEC serves a large portion of southwest/southcentral Arkansas to provide required assessments (Learning Media Assessment, Functional Vision Assessment, Orientation & Mobility Assessments, Assistive Technology Evaluations) consultations, and recommendations for adaptations and modifications to meet the needs of students who are blind or visually impaired, ages 3 through 21, in an educational program. The ESVI Consultant also loans adaptive equipment to students in school districts and provides large print/braille textbooks through our Instructional Resource Center. Consultation, required assessments, recommendations and instruction in the area of orientation and mobility is provided in the schools and local communities. In addition, professional development opportunities are offered to parents, teachers and related staff. The counties served by the SWAEC Vision Consultant are: Polk, Scott, Pike, Montgomery, Columbia, Union, Ouachita, Nevada, Lafayette, Miller, Hempstead, Howard, Sevier, and Little River.

#### Major Highlights:

During the year 2021-22, the ESVI consultant continued to be housed at SWAEC. This enables continued communication between member districts, other counties and co-ops served, SWAEC, and LEA staff serving special populations. The ESVI consultant provided trainings to areas across Arkansas, teamed with CAYSI Project to work with deafblind students in Arkansas, and attended numerous trainings to gain information and knowledge in skilled areas. Conferences/meetings attended included: Region 7 Meetings, Inclusive Practices. ACC Fall Convening, LEA Academy, APH Annual Conference (provided required ACVREP credit hours needed for O&M certification), Ar-AER(provided required ACVREP credit hours needed for O&M certification), International Orientation and Mobility Online Symposium (provided required ACVREP credit hours needed for O&M certification). Inspiring Communication & Literacy, and Texas AER Conference (provided required ACVREP credit hours needed for O&M certification). ESVI provided trainings and meetings for the teachers of the visually impaired and students who are visually impaired in the state: Described and Caption Media Program, Google Training, Accessibility Training, Technology for Today and Tomorrow (provided for students). Attended several staff meetings, consulted with ESVI consultants, and attended LEA meetings across the state in different co-op areas (some face to face, some Zoom). In addition to trainings, the consultant provides direct service to the school districts served, with consulting as needed, attending TEAM meetings/IEP meetings, etc., providing required LMA/FVA/O&M assessments as needed, and direct Orientation and Mobility Instruction to students as needed. During the school year, provided schools/parents/TVI's with needed equipment/materials/resources for in-school and home instruction. Provided and attended trainings, meetings and conferences using face-to-face, Zoom and conference calls

#### **Goal:**

Serve as a liaison between ADE, Office of Gifted and Talented and Advanced Placement, district gifted/talented program coordinators, and parent and professional organizations. Provide technical assistance to meet the State Standards for Gifted and Talented Education and Advanced Placement. Promote gifted education through public awareness and advocacy.

#### **Program Summary:**

As the Gifted and Talented Specialist for SWAEC, my job revolves around making sure that the needs of the gifted learners in our districts are being met. This is only achievable by working with the fabulous GT educators across our nine districts and working hand-in-hand with DESE. On top of working with our Gifted educators who are responsible for meeting the needs of our gifted students in each district, it is also my responsibility to work with our regular education teachers to ensure that they are equipped with the tools necessary for helping our gifted students grow and blossom. Some of the services that I provide are: guiding GT Coordinators in the writing of the program application, pre-monitoring in preparation for monitoring of the program, and updating policies and procedures necessary for compliance. Hosted regular GT Advisory Council meetings to disseminate ADE updates, current trends and issues in gifted education, discuss practices and procedures for program compliance, share ideas and student activity events and dates, and keep abreast of the activities of the professional organizations for gifted and talented (Arkansans for Gifted and Talented Education and Arkansas Administrators of Gifted Education Association). Assisted member schools with various student activities such as Ouiz Bowl, Vlog Competitions, Chess Tournaments, and even a Rubic's Cube Competition. I also provided professional development opportunities, including: Curriculum Differentiation, GT Scope and Sequence, Assessment for Identifying Gifted/Talented, whole group enrichment, how to better meet the needs of our twice exceptional students, classroom management for novice teachers, and creative ways to include Arkansas History into the curriculum with my Eerie Arkansas sessions. One of the big topics that I assisted with this year was helping our school district administrators make decisions about the new Pre AP program that was offered to all of our school districts this year.

#### **Major Highlights of the Year:**

My main goal this year was to try to present opportunities for our gifted learners to feel like things were getting back to "normal." Although COVID had something to say about that, we still provided some great opportunities for our gifted learners to share their talents in numerous GT centered events. Beginning in September, I challenged 3rd-9th grade gifted and talented students in our school districts to compete in our fourth annual Vlog Competition. Over 70 gifted and talented students across our districts participated in this competition. This gave our GT students an opportunity to debate issues, explore their talents in using video, research, and to use their creative talents utilizing technology. The Vlog Competition Award Ceremony was held on December 14th, where we invited all students who participated to join us via Zoom and discuss what they learned from the competition, and we awarded the winners. Also this year, COVID presented a major issue on how we would conduct quiz bowl competitions for the students. We ended up holding our Senior High, Junior High and 7th grade quiz bowls virtually for the students of our nine school districts. The virtual format ended up being a great success, and the students and their coaches were able to compete in their grade level tournaments. We were able to hold our 5th/6th and 3rd/4th grade quiz bowls face-to-face here at SWAEC. On 10/21/2021 we were able to hold a face-to-face Chess Tournament for our Senior High GT students to show off their awesome chess skills. We were also able to hold our Junior High and Elementary Chess tournaments face-to-face on 11/8/2021 and 11/10/2021. It was great seeing these kids in action again. One of the biggest events that we provided for our GT students this year was the Rubic's Cube Competition that we held on 12/9/2021. We held a team event and an individual event for the students to show off their cube solving skills. We actually had a student who won the individual event with a time of 17.3 seconds. It was amazing! Lastly, we had a great interest from GT teachers across our nine districts, as well as from around the state, to hold an Eerie Arkansas session with GT students. We held four virtual Eerie Arkansas sessions with GT students from all over the state (including our districts) where they were presented with information about the Gurdon Light. Their task, after doing some research on their own, was to come up with possible theories of what this strange phenomenon could be, and then, present their theories back to me. The information that they presented to me was absolutely awesome, and it turned out to be not only a great time for all that were attending, but an awesome learning experience for both the students and the educators. I have a feeling that I will be presenting many of these sessions in the future.

#### Goal:

HIPPY is a family focused program that helps parents provide educational enrichment for their preschool children. The goal of HIPPY is to empower parents with the skills, tools, and confidence necessary to work with their children in the home. Parents will view themselves as their child's primary teacher and understand the critical role they play in their child's education.

#### **Program Summary:**

HIPPY (Home Instruction for Parents of Preschool Youngsters) is a home-based school readiness program for families of 3,4, and some 5-year-olds. HIPPY staff consists of a trained coordinator and home-based educators. Parents receive weekly curriculum, along with books and supplies for 30 weeks. Home-based educators deliver the curriculum to the home each week and role play the activities with the parent. The parent teaches the curriculum to their child. HIPPY serves families from all ethnic and racial groups. We have served 50 HIPPY families for the 2021-2022 program year. The staff administered the Ages and Stages Developmental Screening, and the Ages and Stages Social/Emotional Screening to each child, and the pre and post HIPPY involvement parent survey to each parent. The staff is involved in collecting and documenting information on each child for the purpose of entering data into the state data system COPA (Child Outcomes Planning and Assessment.)

#### **Major Highlights of the Year:**

- \* Parent Training- HIPPY 3.0 was introduced to families. HIPPY 3.0 is a virtual curriculum adopted for families who were not comfortable with home visits during a pandamic year. HIPPY has adjusted home visits to include virtual, hybrid, phone calls, and in person visits as needed.
- \* Preschool workbooks, backpacks, books, and craft materials provided for every family for the summer to enrich school readiness learning.
- \* Virtual learning for HIPPY home visitors on ACES and childhood trauma, Family Mapping, which is a 300 question assessment for families to obtain what resources a family may need. Every staff member receives over 30 hours of professional development each year.
- \* 100% pass rate of HIPPY state monitoring

\* Over 100 families attended the end of the year celebration. Families joined together to play games, had a scavenger hunt, ate pizza, and learned the importance of building kindergarten readiness skills throughout the year.

#### **Program Summary:**

This purpose of this grant is to provide professional development and on site support to K-12 literacy teachers in the cooperative area. Professional development and on site support focused on the areas of curriculum, data anlysis, science of reading and differentiated teacher support. It is the goal of the literacy specialist to enhance teacher awareness of current best practices and effective literacy instruction that follows the science of reading.

The literacy specialists work with ELA teams to increase their knowledge of the Arkansas ELA Standards. Through this process, districts were guided through the process of beginning to develop a viable curriculum by identifying essential standards. In addition to standards, curriculuar materials were evaluated and/or purchased to meet the science of reading.

Directed district support was provided in data analysis. Literacy specialist worked with districts to administer and analyze literacy screeners and diagnostic assessments. The data gathered was used to determine how to effectively group students for small group instruction. In addition to grouping, the data was used to develop appropriate tier 2 and 3 interventions.

Professional development was presented to help ensure that required teachers are developing a proficiency in the science of reading. The sessions include K-2 R.I.S.E. and 3-6 R.I.S.E., and all participants were provided on site coaching support. Administrators were provided science of reading assessor training in the form of guided classroom walk throughs and debriefing sessions to discuss the evidence that was documented. Specialist also provided support to align science of reading components with current TESS evaluations.

On site teacher support is customized to meet the needs of individual teachers and district goals. The support includes model lessons, lesson planning, corrective feedback and data analysis. In addition to classroom support, novice teachers were offered Praxis and Foundations of Reading study sessions.

In a coordinated effort with DESE, the specialists have provided directed support to five districts that directly related to school improvement goals. The goals were monitored monthly in virtual meetings with the DESE support team.

In conclusion, the Literacy specialists provided the following student activities: Battle of the Books, Reading Fair and the County Spelling Bee. The activities promoted a culture of literacy and allowed students an opportunity to showcase their knowledge and skills.

The purpose of this grant is to provide professional development and onsite support to administrators, instructional facilitators and K-12 mathematics teachers in the cooperative area. The math specialist works to increase teacher content knowledge and implementation of research-based best practices through high quality professional development aligned with state and national standards in math. Partnering with the Arkansas Department of Education, SWAEC administers the Mathematics Program for grades K-12. Technical assistance is provided to schools using a variety of data, based on priorities within districts, to best meet individual needs for student success.

The Math Specialist currently supports 6 of 9 districts in AR Math QuEST (Quantitative Essentials for Students and Teachers) with a 7th district joining in August. AR Math QuEST is a state-initiated professional development opportunity for exemplary teaching and learning based on NCTM's Effective Mathematics Teaching Practices and the Standards for Mathematical Practice. This two year professional training and support promotes equity and the engagement of all students in meaningful mathematics learning experiences of reasoning and problem solving. This year the Math Specialist supported 37 AR Math QuEST teachers in the coop region with 10 fulfilling their two year commitment. The Math Specialist provided a minimum of 2 visits each semester, with most receiving 3 or more visits per semester. Means of support includes assistance with planning lessons, observing and providing feedback for problem-based lessons, and assisting with a book study. QuEST teachers were given books based on their cohort year: Year 1 Cohort received NCTM's Taking Action and Cohort II received Smith and Stein's The Five Practices in Practice. Current plans are to add approximately 30 more teachers in the 2022-23 school year.

The Arkansas Division of Elementary and Secondary Education (DESE) was awarded a \$3 million grant from the Walton Family Foundation for Phase II funding of high-quality tier 1 mathematics curriculum (T1MC) in schools across the state. Three SWAEC districts applied and were awarded funding for HQIM in their schools. The Math Specialist supported these districts by providing professional development using HQIM, modeling lessons, and general content support.

Several state initiated content-specific professional learning opportunities were offered at SWAEC. These included K-2 Foundations of Number Sense, 3-5 Fundamentals of Fractions, and Geometry Transformations. Additional support was given to novices in our area who were teaching math courses while working on a certification pathway. Means of support included Praxis tutoring, lesson planning, classroom management, and APPEL training and collaboration.

Several campuses included the Math Specialist in PLC meetings. Support was given in the areas of Identifying Essential Standards, Assessment, collecting student data, RTI, instructional routines, and curriculum.

The Math Specialist joined the Arkansas K-20 Math Pathways Task Force as a representative for Southwest AR. This task force is charged with building awareness of mathematics course alignment from K-12 to Higher Ed. Work included efforts to connect Secondary and Post Secondary pathways for improved access and opportunities for students based on their interests and career choice."

A task force was initiated through the AR Math Unit to begin discussions and professional development in the area of Dyscalculia. The Math Specialist is a part of this Task Force. Areas of focus included establishing a state definition, screeners, methods of intervention and building teacher awareness for districts and families.

#### Goal:

\*To improve teaching performance and well-being of novices through the use of, but not limited to, Bloomboard and EdReflect accounts

#### **Program Summary:**

The purpose of the Novice Teacher Mentoring Program is to support the professional growth of novice teachers in southwest Arkansas. Novice teachers are provided with three years of personalized support to meet individual needs through face-to-face meetings, on-site technical support, virtual coaching, on-line PLCs, etc.

This year the mentoring program provided support for 174 novices (73 year one, 54 year two, 35 year three, and 12 experienced out-of-state teachers). New novices received "The First-Year Teacher's Survival Guide," "The Classroom Mangement" book, and "The New Art and Science of Teaching" handbook. Year 3 teachers were given eBooks: Working with Students: Boys in Crisis: Research Based Strategies; Before You Quit Teaching and eBooks and webinars: A Framework for Understanding Poverty; Emotional Poverty. Dr. Sain joined SWAEC twice this year to provide our novice teachers with Culturally Responsive Teaching practices.

Each week, novice teachers received a Mondays Mentor's email with an inspirational message along with tips for a successful school year with topics that ranged from classroom management strategies to instruction and planning. The weekly message also contained information about current professional learning opportunities, webinars, and how to access support for Praxis and Foundation of Reading assessments. The R&R worked closely with SWAEC content specialists to help provide novice teachers Praxis and Foundations of Reading assessment support, content support, scheduling support, small group support, classroom management support, virtual tools support, etc.

Each month, teachers were given opportunities to meet virtually with the R&R concerning questions or ideas in which they needed assistance and any emotional support they may have needed. On-site visits were made to novice teachers for classroom management/procedures/routines support and when areas of need in content were identified, the R&R worked with SWAEC specialist to help provide support. Monthly topics were also addressed in various formats: email, virtual zooms, articles, Teaching Channel, etc. on ideas such as: Parent Teacher Conference advice, appropriate report comments, substitute folder ideas, etc.

This year the mentoring program created a new event, "Novice Day of Learning." This monthly event allowed the teacher (or administrator) to customize a learning experience that was specific to the novice's individual learning needs. Those that attended these events appreciated the smaller atmosphere and gave feedback that the learning was very beneficial.

All teachers, including those on alternative certification pathways, were given opportunities of Praxis support and Foundations of Reading support through checkout materials, 240Tutoring, & individualized tutoring sessions (upon request). This information was shared weekly through the Monday Mentor's Message, and tutoring sessions were posted on the novice teacher website and DESE website.

Information concerning novice teachers was given to building and district leaders in the SWAEC Recruitment and Retention Report throughout the school year.

#### **Program Summary:**

Edie Greenwood, SWAEC CHNS retired in October 2021. Lori Arnette, BSN, RN was hired February 2022 at SWAEC CHNS.

The Community Health Nurse Specialist is employed by Arkansas Department of Health and functions in a collaborative role with Southwest Arkansas Education Cooperative. Technical assistance is provided to the region's school district nurses and community coalitions through education and policy guidance and school health advocacy, with special focus on Best Practices for Nutrition, Physical Activity, Injury Prevention, and No-Tobacco. During the 2021-2022 school year the CHNS continued to provide support services to local school districts and nurses

CHNS activity related to the school setting include advocating for the implementation of tobaco-free policies, best practices for tobacco prevention education, and best practices for promoting and impletmenting policies and porgrams for nutrition, physicial activity, and emerging public health issues in the school-age child. The CHNSs provide education for school nurses and wellness committees on the health issues such as the consequences of tobacco use, injury prevention (intentional and unintentional), oral health, infant mortality, physical activity and nutrition. SWAEC CHNS is a CPR Instructor and trains school staff, nurses, and community member in the American Heart Association's CPR/AED and First-Aid training programs. The CHNSs assist schools in the implementation of laws that affect the health and wellness in the school setting, and offer assistance to schools on developing and maintaining wellness committees as required by Act 1220. The CHNSs offer assistance with new tobacco laws, new or changing rules and regulations (kindergarten physical, immunizations, etc.), and train school nurses on all mandatory screening (Hearing, Vision, BMI, & Scoliosis).

Under the ADH, CHNSs are able to offer free NCPD (Nursing Continuing Professional Development) on certain workshops to school nurses to maintain their professional licenses. CHNSs survey school nurses and school staff to offer training and workshops that meet the needs of school health.

CHNSs offer programs and presentations to the students on school campuses in an assembly or classroom setting and are available as presenters and can assist in finding presenters to meet the schools' needs. The SWAEC CHNS has planned and will facilitate, and /or will present at several workshops this summer for school staff, wellness committees, and nurses both at SWAEC and at other co-ops in the SW Region.

Southwest CHNSs (Dawson, DeQueen/Mena, South Central, and Southwest Co-op CHNSs) work closely together to meet the needs of Southwest Arkansas. CHNSs and CHPSs provide regional training to provide a level of consistency throughout the SW Region and cross borders to assist in other school districts to meet the needs of the school.

Activities of the CHNSs related to the community setting include health fairs to promote health and wellness to the communities. Health fairs may also be on the school campus, in the community, or at a local job site. Health presentations are offered to community clubs (Lions Club, Rotary Club, minority clubs, etc.), worksites, and anyone else who requests these presentations. Here is a list of a few examples of presentations the SWAEC CHNS and CHPS can present in the community: CPR, First Aid, Summer Safety, Colorectal Education, Tobacco Education, STD/Reproductive Health, Stop the Bleed, etc. CHNSs attend several statewide meetings and trainings to stay abreast of school health topics and issues and collaborate at the state, regional, and local levels to provide continuity between the Arkansas Department of Education and the Arkansas Department of Health for the health of our students. CHNSs also work closely with Arkansas Children's Hospital, local hospitals, Arkansas Center for Health Improvement (ACHI), State Injury Prevention, Arkansas Cancer Association, Arkansas Prevention Resource, and State and local police. The SWAEC CHNS is a member of four county health coalitions. She attended state CHNS/CHPS meetings and other regional and local meetings. By partnering with local health unit administrators, she strives to meet the health needs of the community. Southwest CHNSs (Dawson, DeQueen/Mena, South Central, and Southwest Co-op CHNSs) work closely together to meet the needs of Southwest Arkansas. CHNSs and CHPSs provide regional training to provide a level of consistency throughout the SW Region and cross borders to assist in other school districts to meet the needs of the school.

The major highlights of the 2021/2022 school year include providing updated mandatory screenings for Vision/Hearing/Scoliosis/ Obesity Prevention (BMI)in a blended learning format. This format was created by SCS CHNS and was used statewide. The blended learning included two parts. Part one was the online training with a pre and post test and instructional videos. Part two was an in person or live event for the school nurse to demonstrate the skills that were learned. Videos were provided by SCSC CHNS and Dawson Co-op CHNS/CHPS. School nurses who completed the blended learning throughout the state were: Vision - 117 participants, Hearing - 117 participants, Scoliosis - 128 participants and BMI - 147 participants. All received a certificate of completion.

Presentations at schools and community events were limited during the beginning of 2021-2022 school year due to Covid 19 pandemic. During spring of 2022, schools and communities opened up to CHNS for health presentations.

# Goal:

Our goal, through these programs, is to provide quality professional development training, primarily in the 13 critical areas, as outlined by the Arkansas Department of Education. The focus is to assist area schools in meeting the needs of their individual School Improvement Plans and to improve student achievement. These training sessions are funded through our Professional Development Consortium (PDC), in which seven of our nine districts participate. Participating districts contribute \$100 per certified staff member to the consortium. This funding helps support training sessions that cover a variety of related topics for which teachers and/or administrators have expressed a need. These funds are also instrumental in supporting several state initiatives, such as RISE, Science GPS and Teacher Evaluation. Districts not participating pay a per session fee.

#### **Program Summary:**

The Teacher Center Coordinator has a primary responsibility for planning and carrying out the Professional Development Program for member districts. The professional development programs are, in part, identified by the Teacher Center Committee as a priority among member districts. A wide variety of workshops and seminars are provided for teachers and administrators throughout the year, utilizing the expertise of regional, state and national consultants to train school personnel to help them develop both professionally and personally. Collaboration with the ADE and other agencies exists to provide professional development for specific groups such as: Special Education Teachers, Limited English Proficiency Teachers, Federal Coordinators, Gifted and Talented Teachers, Food Services, and Migrant Educators. Technology is supported through a variety of training sessions here at the Co-op and at the school sites.

#### **Program Summary:**

The purpose of this grant is to provide professional development and on site support to K - 12 teachers of science in the cooperative area. The professional development and support include a variety of state level and local level services. The science specialist position was filled in July of 2021 after a year of the cooperative being without a science specialist.

On site support included over seventy school visits, in both individual and group settings, ranging from PLC support, direct teacher support with lessons and assessments, and mini-presentations on various topics. Occasionally, the specialist assisted with some peripheral support, e.g., helped a teacher with an IMPACT application, assisted National Board applicants, recorded video of instruction for EdTPA submission, and provided specimens/materials for a particular lesson or unit.

The specialist offered nine science professional development sessions during June and July of 2022 and four sessions at the #teachsouthwest mini conference in the summer of 2022.

At the ADE Summit, the specialist co-presented a science session, "Scientific Models: Tools for Predicting, Sense-Making, and Engineering."

The specialist collaborated with the science specialist at DESC and the Digital Learning Unit to design and develop an asynchronous Canvas LMS course to be used as a prerequisite introductory course for teachers who are unfamiliar with the Arkansas K-12 Science Standards. The course is available to all cooperatives statewide.

At the state level, the specialist collaborated on an exemplar grade two science unit that is available statewide to model the attributes of a three dimensional, phenomenon driving instruction that is aligned with the Arkansas K-12 Science standards and the student centered vision of the NGSS.

The specialist supported the new Arkansas STEM Model School Designation certification process. The specialist gave an informational presentation to the SWAEC Board of Directors and Lunch and Learn administrators to provide an overview of the process. At the time of this writing, one school in the SWAEC area is showing interest and may be the first school in SW Arkansas to commit to the year-long process. The Specialist is the support for the schools entering the process, providing assistance with the detailed self assessment phase of the application. Aligning with the mission of the Arkansas Initiative for Instructional Materials, the specialist, an EdReports reviewer and EdReports Klawe fellow, attended the Spring 2022 Arkansas Teaching and Learning Collaborative and the National ASCD conference. The specialist delivered an HQIM informational presentation to the cooperative board of superintendents and the Lunch and Learn group of school administrators. The specialist also supported the 3 -12 science curriculum adoption process in a cooperative district by providing information, tools, and resources to expedite the process.

The specialist served as a member of the Arkansas Data Science and Computing Ecosystem and is a member of the Southwest Arkansas Team.

As ancillary activities, the specialist supported the SWAEC Battle of the Books, Book Fair, Quiz Bowl, and served as a board member of the Regeneron Ouachita Mountains Science and Engineering Fair (HS) and the Broadcom Masters Ouachita Mountains Science and Engineering Fair (MS).

#### Goal:

The purpose of the Teacher Center is to provide services to our schools in three basic areas: staff development, curriculum development assistance, and educational materials. We meet those goals in a number of ways in both the Teacher Center and other areas of the Co-op. The Teacher Center Advisory Committee works closely with the Teacher Center staff and the Co-op Board of Directors. This open channel of communication assures that we continue to understand and meet the needs of educators we serve.

#### **Program Summary:**

The SWAEC Teacher Center provides a place for teachers, paraprofessionals, and administrators of all member districts to work on instructional materials, develop curriculum, and obtain instructional and media materials to meet the needs of their classroom. The instructional materials have been developed to coordinate with the Arkansas Standards. Instructional resources are available for teachers to use in the classroom. The primary focus of the instructional material is reading, math and language arts; however, we do have materials available for other subject areas. Technical assistance is available for educators, from laminating and supplies to curriculum designed to meet a specific need. One of the most popular services of the Teacher Center is the Ellison lettering machines and the numerous dies available for use. During the school year, the SWAEC makes Ellison cuts available to schools through six Ellison kits that travel to different buildings. Additionally, the Teacher Center provides teachers and administrators the use of a banner/poster maker, a binding machine, two laminators and copiers. Teachers use the Teacher Center on a regular basis for help and assistance through personal visits, phone calls, and school visits through the delivery system. The Center serves preschools and daycares, in addition to our member school districts. There are approximately 35 preschools and daycares that use the SWAEC Teacher Center services on a regular basis. Students from UAHT, Texas A&M-Texarkana and Henderson regularly use the SWAEC Teacher Center services. Private schools in the SWAEC service area also use the Teacher Center.

The goal of **Explore Success 8th Grade Career Exploration Event** is to create school-business partnerships, expose students to local employment opportunites, and align Student Success Plans with local business and industry in southwest Arkansas. The goal of **Explore Success 11th and 12th Grade Career Fair** is to expose 11th and 12th graders to local employers, job requirements, and job opportunies they may be interested in upon graduation.

#### **Program Summary:**

Both Explore Success events are annual events in their second year. Beginning in July, the SWAEC CTE Coordinator begins collaborating with SCSC CTE Coordinator, DMESC CTE Coordinator, UAHT, Southwest Planning & Development District, and Southwest Arkansas Developmental Alliance (SADA) for the 8th Grade Career Exploration Event. Our partners work together to invite local area business and industry representatives, college representatives, and southwest Arkansas students to come together in October for the event. Partners plan an agenda featuring Paul Vitale, motivational speaker and author, to host our event. Over 1500 eighth graders attended this career exploration event supporting Student Success Plans. The event was in conjuction with the Ready for Life Platform showcasing SW Arkansas business and industries for students from across the region. As soon as the 8th Grade Explore Success Event passed, the partners began planning for Explore Success Career Fair for 11th and 12th graders. This year's Career Fair was cancelled to reevaluate the format into a Reverse Career Fair for 2023. A Reverse Career Fair will require students to present to employers their certifications and skills. Training for teachers to have students participate in next year's Explore Success: Reverse Career Fair was offered in June 2022.

#### **Program Summary:**

- \*Even though I was bound and determined to provide a somewhat normal year of quiz bowl competitions for our gifted learners, COVID still had a tight grip on what we were able to do. We did persevere and were able to provide our district quiz bowl teams with opportunites to compete. We had to hold our senior high, junior, and 7th grade competitions virtually because of the resurgence in COVID during that time of the year. We were able to hold our senior high tournament on 1/19/2022, our junior high tournament on 1/24/2022, and our 7th grade tournament on 1/31/2022. Even though we had to hold the tournaments in a virtual format, the students still enjoyed the process and were able to match their intelect with students from around our co-op area. We were actually able to hold our 5th and 6th grade quiz bowl on 3/10/2022 and our elementary quiz bowl on 4/7/2022 face-to-face here at SWAEC. # **Program Summary:**

The SWAEC Reading Fair is a way for participating schools to provide students with the opportunity to share a favorite fiction or non-fiction book through a project board display or a presentation utilizing technology. Each participating school was allowed to enter the top 3 entries for each division for each grade. This means the schools could have brought 3 Fiction Project Boards, 3 Nonfiction Project Boards, 3 Nonfiction Technology Presentations, and 3 Fiction Technology Presentations per grade. Students registered as an individual or as a team of two. In 2022, we had 136 projects submitted and 6 schools participated.. There were a minimum of two judges for each grade level. A 1st, 2nd, and 3rd place winner was selected for each division per grade. All divisions were scored using a rubric, and 1st, 2nd, and 3rd place winners received a medal. All students who participated received a participation certificate.


