The following community members addressed the Board: Michele Martin, Kim Krutka, Kelly Born, Lenry Van Zyl, and Debi Scaggs.

Discussion of Safety & Security Update Dr. Jeff Russell, Area Superintendent provided the Board with a review of present District security procedures as well as highlighted security precautions and reviewed enhancements that the district has implemented in regard to student and staff safety. Dr. Russell stated Denton ISD received a grant to install impact resistant film at all campus entryways and a district-wide standard response protocols, additional SRO officers were added to all high schools in partnerships with local communities and a Safety & Security Director in partnership with the City of Denton. An anonymous tip hotline Stopit was implemented, upgrades to security cameras and campus check-in procedures were refined.

Discussion of Teacher Recruitment and Retention Jason Liewehr, Executive Director for Human Resources provided the Trustees with information regarding recruiting and retention of teachers and staff for Elementary and Secondary Schools. Jason reviewed hiring data for teachers, recruiting strategies and an overview of internal supports for Denton ISD staff. Some of the most important items teachers consider for a potential teaching job is salary, school culture and the principal. Emily McLarty, Director of Staff Engagement provided information on the processes HR utilizes to retain staff. They provide staff a sense of belonging, mentorship, professional development tailored to a person's needs and interests, and leadership that cares about and invests in the person.

Discussion and Review of Secondary Course Planning Guides Dr. Lisa Thibodeaux, Director of Secondary Curriculum provided the Trustees with the updates that are made each year to the High School and Middle School course planning guides. These course planning guides provide parents, students and staff with a readily available accurate source of information related to district courses, course planning and related policies and practices.

Discussion of 2023-2024 School Calendar Susannah O'Bara presented the 2023-2024 school calendar to the Trustees and reviewed the start/end date, instructional minutes, scheduled holidays, and built-in PLC days.

Current state law requires that school not begin prior to the fourth Monday in August. With acceptance of the proposed DOI plan, Denton ISD may pursue an exception to this legal requirement. Based upon current survey and feedback from EIC, Principals, City Council PTA and Executive Cabinet, the following considerations were made in developing these calendars:

- HB 2610 requirement of 75,600 instructional minutes.
- Ending the first semester prior to Winter Break.
- Equalizing the instructional days/minutes in each semester to the greatest extent possible.
- Maintaining a consistent holiday schedule with prior years and alignment of spring break with local universities.
- Potential waiver minutes of 2100 for professional development.
- Maximizing use of instructional minutes prior to state testing.
- 180 Instructional Days
- A student/staff holiday at least once per month.
- Ongoing PLC time for professional learning.

The projects currently under construction are Calhoun Middle School replacement campus, LaGrone Academy additions and renovations, Newton Rayzor Elementary replacement campus, Transportation East and Cheek Middle School.

Growth Report for 3rd Quarter 2022

Rocky Gardner, Zonda presented the 3rd quarter growth report. The unemployment rate in the DFW area is around 3.4 %. Spring of 2022 the interest rate was 3.5 % and the median home price was \$343,221. Fall of 2022 the interest rate is 7% with a median price of \$365,700 carrying a \$2700 monthly payment which is a 45% increase in monthly payments from the Spring. Denton ISD ranks second in the DFW area with the most home starts, closings and future lots. The district has 64 actively building subdivisions within DISD. There are 34 future subdivisions and of these, groundwork is underway on 3,867 lots within 21 subdivisions. The district has nearly 4,150 multi-family units under construction across the district, including roughly 1,120 single family rental units. Within DISD there are over 7,100 future multi-family units in the planning stages. Denton ISD

added less than 600 students last year and this was the smallest one-year change since 2015/16, with the exception of 20/21 (COVID). The district is forecasted to enroll more than 36,200 students in 2027/28 adding almost 4,000 students.

Nicole Goodman, Director of Health Services provided the Board with an annual update on the current processes within the health services department. This School Year the district nurses provided the following:

- 96,000 Office Visits
- 17,000 Individual Students
- Completed Vision, Hearing and Spinal Screenings
- Ensured Students Had Access To Care

The campus nurses also assist in coordinating annual flu vaccines and facilitate on-site staff training as well as connecting with community partners such as Denton County Public Health, PediPlace, North Texas Allergy/Asthma Center and Kiwanis Club of Denton.
