## RESOLUTION DENYING ANY CONTINUING CONTRACTUAL RELATIONSHIP WITH PAP CONSULTING

WHEREAS, the Board of Education of Harvey School District No. 152, Cook County, Illinois, has previously used the services of PAP Consulting, Inc. ("PAP") from time to time for the purposes of preparing and submitting annual applications to the Illinois State Board of Education for recalculation of General State Aid ("GSA"); and

WHEREAS, however, there is and has been no binding contract for continuing services between the Board and PAP;

WHEREAS, PAP has this year and in some past years submitted applications on behalf of the Board without the approval of the Board and has misrepresented to the Administration the status of its contractual relationship with the Board;

WHEREAS, the Board of Education finds that the best interests of the District require an express denial of any continuing contractual relationship with PAP;

NOW, THEREFORE, Be It Resolved by the Board of Education of Harvey School District No. 152, Cook County, Illinois, as follows:

- 1. The foregoing recitals are incorporated into and made a part of this resolution.
- 2. The Board herein expressly (a) denies the existence of any continuing contractual relationship with PAP, (b) rescinds to the extent necessary the approval of any existing contractual obligations with PAP for good cause based on PAP's actions as expressed herein, (c) disapproves any authority for PAP to prepare and submit any further applications for the recalculation of GSA in 2015 and each succeeding year and for 2009 and each succeeding year, and (d) directs the Administration not to authorize any further use of or payments to PAP.
