The total tax collection rate for July 2024 was 99.40% and 99.39% for July 2025.

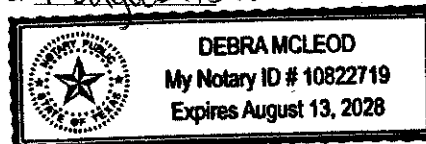
