**Agenda Item:** Consider and take action regarding approving Positive Insight Counseling Agreement for the 2025-2026 school year.

### CONSENT ITEM

#### **RECOMMENDATION:**

To approve the 2025-2026 Agreement with Positive Insight Counseling to provide counseling services for Judson ISD students and families.

#### **IMPACT/RATIONALE:**

Positive Insight Counseling will provide contract services for our wraparound program to assist our Judson ISD students and families. Services include wraparound center and school-based individual or group counseling. This agreement will allow Judson ISD to partner with Positive Insight Counseling for students and families who are experiencing a gap or delay in services due to extensive waiting lists, lack of available services or out of pocket expenses. Programming costs covered through the American Rescue Plan Act Grant that was awarded in March 2023. Grant funds are dedicated for counseling services to meet student and family needs. Program costs are based on services provided and not given based on a flat fee. The grant is billed based on use of services by Judson ISD families and students. Counseling services may be requested by school counselors, social workers, administrators or families directly.

### **General Description of Service:**

Positive Insight Counseling/Tamara Mobley-Wicker, LPC will provide individual and group school-based and Wrap Around Center counseling services for students of Judson ISD. Counselors will also be available to provide after hours counseling for the students of the district and their families as well as any district crisis counseling services determined by the Student Family and Support Services. This will provide cost effective support for the students of Judson ISD.

### **Scope of Project:**

Positive Insight Counseling/Tamara Mobley-Wicker, LPC will provide one counselor to provide individual, family and crisis counseling for the students of Judson ISD. Positive Insight Counseling counselor will provide brief/solution focused counseling for students referred to by the school counselors or social workers, parent request and or requested by campus administration. The counselor will provide a service log sign-in sheet to monitor the hours of clinical contact with the students. The counselors will also provide their own liability insurance for the protection of all parties.

Intake, note taking, and termination paperwork will be decided on jointly between Positive Insight Counseling and school district personnel. Exit survey and other data collecting methods may be used upon the request of the district. The proposal is for counseling services for the duration of the 25-26 school year.

The cost is broken down as the following:

One counselor will provide weekly services. This is during the 2025-2026 school year.

July 1, 2025 - June 30, 2026

Total: \$76,500

Monthly rate: September-May - \$8000

Monthly rate: July, August, June - \$1500

Weekly rate will be paid monthly upon services rendered.
