Kenyon-Wanamingo Schools – ISD 2172 School Board Meeting Minutes – January 27, 2025

I. Call Meeting to Order

Chair Craig called the meeting of the Kenyon-Wanamingo Board of Education to order at 6:00 p.m. in the elementary media center followed by the Pledge of Allegiance. Members present: Tonya Craig, James Jarvis, Marilyn Syverson, Debb Paquin, Erica Aronson, Madilynn Lurken, AJ Lindell (remote) and ex-officio member Superintendent Beth Giese.

IV. Public Hearing on the proposed closing of Kenyon-Wanamingo Elementary School
Chair Craig stated we would proceed with the public hearing portion of the meeting. The purpose of
this hearing is to address the School District's reasons for proposed closure of a public school
building and to allow the public to provide testimony for and against the proposed school closing.
The process of over which the chair is residing has been established by statute and for the purpose
of providing notice to the public of the description and location of the school that the School District
has proposed to close, as well as the rationale behind the proposed closure. The hearing also
provides members of the public the opportunity to testify about the proposed closing. The
hearing provides members of the School Board the opportunity to consider the testimony and
evidence on this issue. Superintendent Giese reviewed the published notice of public hearing
regarding the closing of the Wanamingo School Building and affidavit of publication and the
resolution providing for a public hearing on closing a schoolhouse. Superintendent Giese also
briefly reviewed the timeline history on this process.

V. Discussion on proposed closure options

Chair Craig asked for discussion on three options; leaving the building as is, reorganizing the Wanamingo site to house Preschool and Knights Kids or full closure of the Wanamingo building and moving to all programs to Kenyon site. All three options were discussed, and public testimony was received.

- VI. Consideration and possible action related to proposed closing of the Kenyon-Wanamingo Elementary School; selection of proposed closing options 1, 2 or 3.
 - Member Lindell suggested moving to the consideration stage. Member Jarvis motioned to repurpose the Wanamingo site and have it house the Preschool and Knights Kids. There was not a second. Motion failed. Member Lindell motioned to approve the option for full closure of the Wanamingo building. This motion was seconded by Erica Aronson. The resolution below was then introduced.
- VII. Resolution to Close the Kenyon-Wanamingo Elementary School

 Member AJ Lindell introduced the following Resolution and moved its adoption:

 RESOLUTION TO CLOSE THE KENYON-WANAMINGO ELEMENTARY SCHOOL

WHEREAS, pursuant to Minnesota Statutes, section 123B.51, subdivision 5, and after publication of due notice, the School Board held a public hearing at 6:00 p.m. on January 27, 2025, on the proposed closing of the Kenyon-Wanamingo Elementary School, located at 225 3rd Avenue, Wanamingo, Minnesota 55983;

WHEREAS, the public hearing was conducted by the School Board;

WHEREAS, during the public hearing the Administration of the School District presented a proposal to close the Kenyon-Wanamingo Elementary School because of declining enrollment and the resultant loss of revenue, budgetary reasons, and the practicability and efficiency of providing services currently offered in the schoolhouse in alternative locations;

WHEREAS, during the public hearing, the public was invited to provide testimony for and against the proposed closing of the Kenyon-Wanamingo Elementary School.

NOW, THEREFORE, BE IT RESOLVED by the School Board of Independent School District No. 2172 as follows:

- 1. After consideration of all relevant facts and materials, including the testimony and materials presented at the public hearing, and the attached Findings and Conclusions, the School Board hereby determines that closing the Kenyon-Wanamingo Elementary School is both necessary and practical.
- 2. The attached Findings and Conclusions of the School District's Administration are hereby adopted and incorporated as those of the School Board.
- 3. The Kenyon-Wanamingo Elementary School shall be closed, effective June 30, 2025, or as soon thereafter as practicable.
- 4. The Superintendent is directed to make all necessary arrangements to close and secure the Kenyon-Wanamingo Elementary School and to transfer present programs, activities, work sites, records, salvageable equipment and materials to other locations as deemed appropriate.

Member Ericka Aronson seconded the foregoing Resolution and upon vote being taken thereon, the following voted in favor thereof: Craig, Lindell, Jarvis, Paquin, Aronson, Lurken, and Syverson. And the following voted against the same: None.

Whereupon said Resolution was declared duly passed and adopted.

Chair Craig called for a break at 6:57 p.m. Meeting resumed at 7:05 p.m.

WHEREAS, this reduction in expenditure and decrease in student enrollment must include discontinuance of positions and discontinuance or curtailment of programs, and

WHEREAS, a determination must be made as to which teachers' contracts must be terminated and not renewed and which teachers may be placed on unrequested leave of absence without pay or fringe benefits in effecting discontinuance of positions,

BE IT RESOLVED, by the School Board of Independent School District No. 2172, as follows:

That the School Board hereby directs the Superintendent of Schools and administration to consider the discontinuance of programs or positions to effectuate economies in the school district and reduce expenditures and, as a result of a reduction in enrollment, make recommendations to the school board for the discontinuance of programs, curtailment of programs, discontinuance of positions or curtailment of positions.

The motion for the adoption of the foregoing resolution was duly seconded by Member Marilyn Syverson and upon vote being taken thereon, the following voted in favor thereof: Craig, Paquin, Syverson, Jarvis, Aronson, Lurken, and Lindell and the following voted against the same: None whereupon said resolution was declared duly passed and adopted.
