Resolution Ascertaining Prevailing Wages

Community Unit School District 304- Kane County, IL 60134

The State of Illinois requires local school boards to adopt the attached Resolution that asserts that all general contractors performing work on behalf of the District are paying prevailing wages in accordance with Kane County, IL prevailing wages. RESOLUTION ASCERTAINING PREVAILING WAGES IN COMMUNITY UNIT SCHOOL DISTRICT #304 KANE COUNTY, IL

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics, and other workers employed in any public works by State, County, City, or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, codified as amended, 820 ILCS 130/1 et seq. (1993), formerly III. Rev. Stat., Ch. 48, par. 39s-1 et seq. and,

WHEREAS, the aforesaid Act requires that the Board of Education of Community Unit School District #304 investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics, and other workers in the locality of Kane County employed in performing construction of public works, for said Board of Education.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF EDUCATION OF COMMUNITY UNIT SCHOOL DISTRICT #304:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics, and other workers employed in any public works by State, County, City, or any public body or any political subdivision or by anyone under contract for public works, "approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics, and other workers engaged in construction of public works coming under the jurisdiction of Community Unit School District #304 is hereby ascertained to be the same as the prevailing rate of wages for construction work in Kane County area as determined by the Department of Labor of the State of Illinois as of June, 2014. The most current prevailing wages, referenced at http://www.illinois.gov/idol/Laws-Rules/CONMED/Pages/Rates.aspx are being incorporated herein by referenced link. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by Community Unit School District #304. The definition of any term appearing in this Ordinance which is also used in aforesaid Act shall be the same as in said Act. SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of Community Unit School District #304 to the extent required by the aforesaid Act.

SECTION 3: Community Unit School District #304 shall publicly post or keep available for inspection by any interested party in the main office of Community Unit School District #304 this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: Community Unit School District #304 shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who has filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose rates will be affected by such rates.

SECTION 5: Community Unit School District #304 shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION 6: Community Unit School District #304 shall cause to be published in a newspaper of general circulation within the area, a copy of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
