# **Back-to-School Questionnaire**

1,544 responses out of 1,748 students (88%)

1,252 out of 1,544 students are attending in-person (81%)

263 out of 1,544 students are opting into the online environment (17%)

29 students will not return to Granby Public Schools (move, homeschool, etc...)

## **Transitional Entry**

- Local decision as long as there is an in-person component
- Consultation with Farmington Valley Health District
- Establish healthy and safety routines in smaller groups
- Ease students and staff back into school after extended closure
- Build relationships
