Business or Accounting CTE Teacher, Badger High School Grades 7-12

Badger Community School is seeking a full time business or accounting teacher for the next 2024-2025 academic year. The qualified applicant may be responsible to teach courses such as the following, but not limited to, accounting, introduction to business, career exploration, computer applications, entrepreneurship, marketing, and personal finance to grades 7-12. This position has the support of a dedicated staff which is a vibrant mix of veteran and younger educators focused on serving the needs of students and each other.

Badger is a stable right sized smaller school near the northern border of greater Minnesota located on state highway 11. It does not take too much imagination to come up with four seasons of fun with the neighboring forest areas, inviting rivers, wetlands, recreational trails and golf courses in close proximity to Badger. Also, less than an hour drive to Lake of the Woods for boating, camping and some of the best year-round fishing in the state.

Pay and Benefits: Starting pay for 2024-2025 will be no less than 47,062 and may be up to \$75,235 based on education and experience along with a comprehensive benefit package.

Preference will be given to candidates with the willingness to work toward obtaining a Career and Technical Education (CTE) funding-eligible teacher licensure in the future or credentialed to do so already.

Licensure: Valid Minnesota teacher license in business or accounting; otherwise the ability to obtain such licensure by August 26, 2024 for either grades 7-12 or grades 5-12.

Candidates with training, degrees or licenses in other related content areas are also welcome to apply. Badger School is willing to explore a Career Pathways Tier 1 or Tier 2 license application. A Career Pathways licensure candidate is not required to hold a four-year bachelor's degree. The candidate must verify five years of closely related work experience, a two-year associate's degree, or a professional certification from an approved certifying organization that is directly aligned to the CTE or Career Pathways licensure field being requested. A four-year bachelor's degree may be used in lieu of the above requirements.

If a candidate already holds a Tier 2, 3, or 4 teacher license in a different content area, the district may be willing to explore an Out of Field Permission (OFP) if necessary within accordance of PELSB guidelines and timelines.

Other income opportunities may also include co-curricular advising, directing or coaching athletics; however, not required.
