The following team guidelines are submitted for approval effective March 2011.

#### I. Tryouts

- a. Spring tryouts will be held during the first part of March or April. The time period will be selected to prevent conflicting with any testing period and/or any previous school activity.
- b. If deemed necessary by the director and principal, tryouts can by held any time throughout the school year as long as it does not conflict with any school activity.
- c. No maximum or minimum number of girls is required for the team.
- d. A week of practice will be held with the required dance, kick routine and split combination.
- e. Judges may include team directors and two or three selected judges upon approval from the principal and/or principal's designee.
- f. All candidates must have a signed permission slip from their parents acknowledging their daughter's intention and parental signatures indicating their agreement to support the team's requirements and guidelines.
- g. All candidates must be in good health, free from any illness or conditions that would endanger their well being during the week of practice. A current physical must be complete and submitted by the first day of practice. Physical strain and/or injuries could result from an unconditioned candidate. WHS, the director, team, and district are not responsible for any injuries sustained during the camp week.

- h. To be eligible, all candidates must submit two current teacher recommendations. One teacher from a Language Arts teacher and the other one must be an academic teacher (no electives). Recommendations must be received by Friday afternoon before tryouts.
- i. A member must be a student of Waskom High School for the upcoming year and be academically eligible on the first day of the new school year.
- j. All team members must be in attendance at all tryout practices.
- k. Tryouts will be held the morning of Saturday following practice week. Any conflicts occurring with the tryout morning should be brought to the director's attention for possible alternative arrangements to be made.
- 1. Transferring students who show interest in the team and who have prior team experience may request a consultation or the team consideration with the director.
- m. Candidates have one day's time period from the day of tryouts to review individual, personal tryout ballots. Team director, school administrator, and parent must be present to review and discuss any concerns with tryout selection. After 24 hours, all ballots will be destroyed.
- n. Results from tryouts will be posted the Monday following tryouts at your respective school.
- o. Any girl who has left the team for any reason, other than submitted and accepted by the director and principal's designee will not be allowed to tryout for the team the following year.
- p. Tryouts are closed to the public.
- q. Candidates must meet U.I.L. eligibility requirements.

#### II. **Officer and Captain Tryouts**

- a. All selected individual officers will be responsible to the overall team's stated guidelines.
- b. All selected individual officers, must have served on the WILDCATS dance team for one year, prior to being eligible for officer status.
- c. Officer tryouts will be open to all girls, if there is an insufficient amount of line members returning.

- d. Any girl who has left the team for any reason, other than a reason submitted and accepted by the director, will not be allowed to tryout for officer the following year.
- e. All eligible candidates will be required to learn or make-up a dance, submit a 2 page coherent typed essay and have an interview with the judges, and/or be able to teach part of a dance.
- f. Officer results will be posted the Monday following tryouts at the high school.
- g. Officer tryouts are closed to the public.

### III. Team Responsibilities/Guidelines/Rules

- a. All WILDCATS must understand that being a member of the is a **privilege, not a** right; and therefore, this privilege may be revoked at any time at the discretion of the director and/or administrator's notification.
- b. All WILDCATS must ride the same bus/van (or approved mode of transportation) to and from games and other activities. No one will be able to ride with anyone else, except parents, guardians; immediate family members who have received prior approval of the team director(s). Allowances for other transportation arrangements must be given to the director(s) in written documentation 24 hours in advance, no exceptions. No one will be allowed to be transported by other means without parent's written permission and the director's approval.
- c. Members must stay in assigned places for the entire game or performance. Visitors are not allowed in the designated seating area of the WILDCATS dance team.
- d. Any WILDCAT not enrolled for any reason other than mandated graduation requirements, or approved reasons by the director, will not be allowed to tryout in the future. All dancers will also be responsible for other assignments such as tryouts in the upcoming year.
- e. Grooming and conduct:
  - 1. Members are expected to be well groomed at all times. One's appearance is a reflection of the organization and Waskom High School.
  - 2. Members are expected to conduct themselves properly at all times.

- 3. Teacher complaint of classroom behavior.
- 4. Failure to dress out for practice. Members must wear appropriate work-out attire or performance attire as designated by director(s) or officers.
- 5. Not abiding by the team's standards (make-up/hair, uniform, etc.)
- 6. Non-attendance to one practice and/or one performance.
- 7. Receiving a disciplinary referral.
- 8. Unwillingness to meet team's standards (stretching, kicks, practice, etc.)
- 9. Two tardies to any practice and/or school function or performance.
- 10. Two excused absences or one unexcused absence. Only excused absences will be accepted as valid reason for missing practice and/or functions. (The team must be contacted, nor another WILDCAT member to explain absences.) Any tardies and absences resulting from work issues are considered to be unexcused. 3 unexcused absences from summer camp will result from removal of the team.
- 11. Any violation of the WISD Students Code of Conduct and/or WHS Student Handbook.
- 12. WILDCATS dance team member MUST attend summer practice/camp to remain on the team. Other activities such as summer school, summer jobs, vacation, other athletic activities, etc. MUST NOT interfere with practice sessions, summer camp, games, pep rallies, or other dance team duties during the summer or any other time.
- 13. Ineligibility for an entire semester will result in removal from the WILDCATS dance team.

14. Members are only allowed to wear uniforms to football games or other school sponsored activity. Members will NOT wear their uniform to any non-school sponsored function.

E. All WILDCATS may be removed from the team for any reason for any of the following reasons:

- 1. Disruptive behavior, such as physical fighting.
- 2. Two ineligible consecutive or non-consecutive marking periods.
- 3. Two suspensions resulting from any violations listed above.
- 4. Serious violations of the WISD Student Code of Conduct and/or the WHS Student Handbook.
- 5. Two non-completions of each function through its entirety.
- 6. All girls, once selected, may also be removed from the team by the director based upon her opinion and judgment of the member's lack of personal attitude, team participation, team contribution, or behavior that become detrimental to the betterment, peace, and cooperation of the entire team.

### Grades

- a. Each member must bring her report card to class at the end of each 6 weeks reporting period to be checked by the director.
- b. A seventy (70) average or better must be maintained in each class at the end of each eligibility period.

c. A member failing to comply with these requirements will be placed on probation according to UIL guidelines.

1. Any probation shall include:

a. The member will not perform.

- a. All officers must set the example of what a WILDCATS Dance Team member should be.
- b. All officers are subject to comply with all team responsibilities, guidelines, and rules.
- c. Any officer with two suspensions violations will automatically be demoted to a line member.
- d. Any officer who becomes academically ineligible will automatically become demoted from their position.
- e. All officers are expected to be present at all practices and function 15 minutes early for roll call.
- f. All officers must attend and perform at all functions.
- g. All officers must chorography routines. Routines and music must be approved by director.
- h. The director and all officers must supervise and are responsible for the actions of the entire WILDCATS Dance Team.
- i. All officers will be responsible for starting practices promptly, for making optimum use of practice time, and for any other duties as designated by the director.
- j. All officers will be responsible for notifying the director of any infraction of rules that might necessitate demerits.
- k. All officers must follow directors' instruction.
- 1. Being an officer does not guarantee a spot in all performances, you must earn your spot through competing with the rest of the line members.
- m. Being an officer does not guarantee a front and center spot in all performances.
- n. All officers, once selected, may also be removed from the team by the director based upon her opinion and judgment of the member's lack of personal attitude, team participation, team contribution, or behavior that has become detrimental to the betterment of the entire team.

#### VI. **Parental Consent and Support**

a. All team member's parents, guardians, and family members should be supportive of the overall benefit and representation of the team, and support the team members in complying with all rules and regulations of the school and the team. ### VII. <u>School District Expenses</u>

- a. Required night and day performing uniforms.
  - 1. Each member is responsible for the care of the official field uniform(s) and all other uniforms.
  - 2. The uniform or any part of the uniform is NOT to be worn unless authorized by the director.
  - 3. Uniforms will be inspected for neatness at all appearances.
  - 4. Members shall not eat or drink in uniform unless authorizes by the director.
  - 5. When a uniform is returned, it must be in good condition (no tears or stains).
  - 6. Members will NOT loan out their uniforms.
- b. All school owned props, pom-poms, garment bags, etc.
- c. Travel expenses for each out of town games and camps.
- d. Letterman jacket at the end of the required time period.
- e. Meals related to all out of town games and camps.

### VIII. Team Member Expenses

- a. Personal uniforms such as bloomers, tights, hose, jazz shoes, jazz pants, leotards, and boots; or any such item that the individual wishes to use. Members must acquire workout clothing (jazz pants, jazz shoes, leotards, etc.) by summer practice/camp.
- b. All transportation to WILDCATS functions held in the Waskom community or nearby areas.

- c. Obligation to reimburse the organization for any non-returnable, fundraising items, which have not been sold after the designated period of sale time.
- d. Obligation to reimburse the school if any issued, school property has been damaged or lost during the issued time frame.
- e. Any personal item the team, as a whole elects to purchase, which will become personal items of the team member.

If a member receives 30 demerits within a semester, that member will automatically be removed from the team. Demerits may be deleted with merits. Merits are awarded to members who go beyond their duties or extraordinary tasks or performance, as according to the director. Three merits delete one demerit. Only the director can issue demerits and merits. Demerits will be given for the following reasons:

Waskom High School will be conducting its yearly tryout camp and actual tryout performance from April 9, 2012 through Saturday, April 14, 2012. Any girls who are enrolled at Waskom High School 2011-2012 school year are eligible for tryouts.

At this time, students and parents are asked to complete the following form granting them permission to attend tryouts. Transportation is to be arranged with personal vehicle.

The following items are required by the first practice date:

- 1. Girls must be punctual in attendance Monday through Friday, 4:30 pm until 6:00 pm for the camp teaching.
- 2. Girls must submit their parental form of consent, medical card information, acknowledgement of rules, and grades.
- 3. Girls must submit two teacher recommendations (core subject areas).
- 4. Girls must wear appropriate shoes (tennis) and practice workout clothes each day of practice (keep in compliance with dress code).
- 5. Physical exam from a local doctor.
- 6. A copy of personal insurance or waiver form must be submitted.

Upon tryout selection, the following items will be needed.

- 1. Attendance at upcoming meeting for summer plans/practice.
- 2. Parental consent and signature of WILDCATS Dance Team Constitution and handbook rules.
- 3. Performance uniforms and make-up must be worn appropriately for tryouts.
- 4. All scheduled practices must be attended.
