3) Approval of Agenda

4) Citizens Request to Address the Board

Todd Claxton addressed the Committee on behalf of the Hinckley Area Food Pantry for a follow up on shared space to use for the Pantry with HBR School District.

5) Updates and Reports

A. Transportation

Andy Lein updated the Committee on an updated transportation replacement schedule. The previous transportation replacement schedule was mainly dependent on staff capacity and the limitations of our facilities. With the expansion into the new building on 540 W Lincoln Hwy, we can now extend the replacement schedule by a considerable amount. Currently we are using the vehicles for a duration of 5 years but with the extended replacement schedule Mr. Lien is looking at 8+ years of use.

B. Buildings & Grounds

There are 2 primary maintenance concerns at 540 W Lincoln; the roof and adequate heating. The larger section of the building is being utilized for bus maintenance and will have pallet racking installed to create storage space. Where the pallet racking will be, the roof is currently leaking. A quote from STA for spraying an insulation layer and then applying an elastomeric roof coating that would be a significant savings over new steel. After initial application, the coating could be reapplied in future years to continue to extend the life of the roof. The installation cost is estimated at \$66,550. Deb Winkle brought up a possibility of just overlaying a new steel roof on top of what we currently have to cut the roof removal cost. Miller Engineering reviewed the space and recommended radiant tube heaters along the north wall and unit heaters by the main garage doors to maintain winter heat. The current unit heaters are not adequate for the space and some are non-functional. The cost for this work would be estimated at \$27,992.

6) Discussion

A. FY26 Projects

Summer projects are currently being planned, including the installation of air handler units 1 and 2 at the middle school scheduled June 2nd. Also at the middle school a glycol flush and replacement in the HVAC system due to a bacteria contamination. Technology updates also scheduled for summer include upgrades to servers, switches and phone systems district wide.

Additional work items for discussion, depending on the budget, include asphalt work on the east side of the elementary school, replacing 2 exterior doors at the elementary and middle schools and installing a new drop ceiling in the elementary school library.

B. Track & Field Area

Brandon Kriesch is currently working on quotes for a 6 or 8 lane track at the middle school. Deb Winkle raised concerns about the current track area potentially being a flood zone, suggesting it should be reassessed before installing a new track. Darrin Gengler asked about including quotes for a long jump and high jump pad as well as the possible need for track lighting. Potential funding could come from Boosters, PTO, Big Rock Lions Club fundraisers or local donations.

Greg Pritchard brought up the fine arts zone at the high school, specifically the seating. Brandon Kriesch received a quote for traditional bleachers at \$130,000 and retractable stadium seating at \$160,000. It may be more cost effective to rebuild the seating risers. The committee will also investigate shifting the theater lights and sound into the gym and raising the stage, so the plays can be viewed from the gym side to allow more seating.
