Basic information:

The Administration is asking the Board to confirm it's intent to renew with the Collective Liability Insurance Cooperative (CLIC.)

CLIC will submit its proposal for Workers' Compensation, Property/Casualty and Student Accident, and Fiduciary Liability insurance coverage renewal for school year 2025-2026 in May of 2025. The renewal is effective July 1, 2025, with annual market review by Arthur J. Gallagher Risk Management Services Inc.

CLIC is requesting that if the District is not going to renew that they give 6 months notice. Therefore, we are bringing the request for renewal for FY 2025-2026 to the BOE prior to Jan. 1, 2025.

Background or historical information:

The BOE has previously approved recommended carriers, as identified by Arthur J. Gallagher Risk Management, for District #33's CLIC renewal for the FY 2007-2008 school term through the FY 2024-2025 school term.

Previous decisions, actions or parameters that relate to this topic or issue:

The annual CLIC renewal meeting will take place in May 2021 and District 33 will receive the proposed FY 2021-22 premium renewal for Worker's Compensation, Property/Casualty and Student Accident, and Fiduciary Liability insurance. The renewal will be presented to the BOE in June 2021 for review.
