**Recommendation:** Approve the amendment submitted by Columbia Advisory Group to provide an interim Chief Information Officer for the College through September 30, 2022.

### **Background and Rationale:**

The College is in the process of hiring a full-time Chief Information Officer (CIO) to serve as the functional lead or the Office of Information Technology. Columbia Advisory Group was previously contracted by the Board in December 2021 to provide interim CIO services until a full-time candidate can be identified and hired. Once the permanent CIO is hired, the current interim will aid in the transition of staff, projects, and duties, as needed. This extension will provide for interim CIO services through September 2022.

# Wharton County Junior College Amendment No. 1 Interim CIO Statement of Work 20 May 2022

This Amendment No. 1 ("Amendment") serves to amend the Interim CIO Statement of Work ("SOW") executed on December 17, 2021, between Wharton County Junior College ("Client") and Columbia Advisory Group LLC ("CAG"). "Party" shall mean either Client or CAG, individually, and "Parties" shall mean Client or CAG collectively.

Except as expressly provided in this Amendment, all other terms, conditions, and provisions of the original SOW shall continue in full force and effect as provided therein.

## **AMENDMENT**

For the consideration provided herein, the Parties now wish to amend the SOW as set forth below. The parties agree as follows:

### **TERM**

Pursuant to Section 1), the Parties agree to execute a renewal for an additional three-month term. This Amendment updates the existing termination date of **30 June 2022** to **29 September 2022**. This is the first renewal executed under Section 1) and reserves 3 remaining renewal as options.

### **FEES FOR SERVICES**

The fees for service remain unchanged, and the updated total contract value is updated as:
