

### **Quarterly Position Report** May 31, 2024



US Treasury bond yields rose by as much as 25 basis points across the curve in the three-month period ending  $\overline{\text{May 31}}$ as expectations increased that the Federal Reserve (Fed) will not change the target rate until later in 2024. The Dow Jones Industrial Average, S&P 500, and Nasdaq-100 indexes reached new all-time highs but finished the three-month period mixed as they returned -0.7%, +4.0% and +3.5%, respectively. The labor market continued to show strength despite a weakerthan-expected April number. In the first five months of 2024, US payrolls added an average of 248,000 jobs per month. The unemployment rate ticked slightly higher to 4.0%. Headline inflation declined from 3.5% to 3.4% after increasing by 0.3% month over month. The figures come as a relief after three consecutive hotter-than-expected inflation reports to start the year. As was widely expected, the Fed held interest rates steady in a range of 5.25% to 5.50% at the May 1 Federal Open Market Committee meeting. The Fed also trimmed its quantitative tightening activity by reducing the monthly cap for Treasury securities from \$60 billion to \$25 billion. At the end of May, the federal funds futures market was pricing in one to two rate cuts for 2024, with the first cut coming in September at the earliest.






