NORTHWEST REGIONAL ESD BOARD MEMBER FOR ZONE 5

POLICY ISSUE/SITUATION

Northwest Regional ESD Board of Directors currently has a vacant position in Zone 5. The Zone 5 position represents the Aloha, Southridge and Westview High School attendance areas. The term will begin on July 1, 2012, and expires on June 30, 2015.

BACKGROUND INFORMATION:

Michael Ingalls has currently served the last four years and is reapplying to fill the vacancy. No other candidates have applied.

NWRESD has divided the four-county region into five zones of approximately equal population. From each of these zones, each school district board has one vote to determine who will represent that zone on the NWRESD Board. The Beaverton School District is represented by Zone 4 (Beaverton and Sunset HS attendance areas) and Zone 5 (Aloha, Southridge and Westview High School attendance areas).

RECOMMENDATION:

It is recommended that the Beaverton School Board discuss and vote on the vacant position in Zone 5.

(12-187) BE IT RESOLVED that the School Board has discussed and cast their vote for the candidate who will serve in Zone 5 on the NWRESD Board.
