## SUMMARY OF CHANGES TO THE 2025-2026 CCISD STUDENT CODE OF CONDUCT

Changes were made throughout, including the addition of a table of contents, changes to some headings, the addition of hyperlinks, restructuring, and reformatting to align the CCISD Student Code to the TASB Model Student Code of Conduct. Additional specific changes include:

16	Language added that the district has not adopted a policy for parental involvement in school disciplinary placements (HB 6).
18	Standard for teacher removals changed to include a single incident of student behavior and to allow teacher the opportunity to participate in the conference (HB 6).
19	Added requirement for written teacher consent prior to returning a student to the classroom and opportunity for student to appeal removal to threat assessment and safe and supportive school team (HB 6).
20	Language added clarifying there is no time limit for in-school suspension, review is required at least once every 10 school days, and behavioral and academic supports are required for students, including special education services specified in the student individualized education program (IEP) (HB 6).
24	Language added allowing out-of-school suspension of students below grade 3 for conduct that threatens the immediate health and safety of other students in the classroom and documented conduct that results in repeated or significant disruption to the classroom (HB 6).
25	Added language providing for an alternative placement to out-of-school suspension with sufficient documentation to be used only in extenuating circumstances (HB 6).
28	Added discretionary DAEP offenses for disruptive activities, disruption of classes, and possession or use of an e-cigarette (HB 6).
29	Removed possession and use of an e-cigarette from the list of mandatory DAEP offenses (HB 6).
40	Expanded the list of mandatory expellable offenses to conduct that occurs on or off school property, including:  o Exhibiting, using or threatening to exhibit or use a firearm  o Kidnapping or aggravated kidnapping  o Burglary, robbery or aggravated robbery  o Assault against a school employee or volunteer (HB 6).
42	Added reference to a virtual expulsion program for situations in which the juvenile justice alternative education program (JJAEP) rejects or releases the student early (HB 6).
42	Added the requirement to consider virtual education as an alternative option to expulsion (HB 6).
49	Added a definition of "Antisemitism" (SB 326).
55	Added a definition of "Personal Communication Device" (HB 1481)
